The Coalition Against Israeli Apartheid delivered an eleven-page letter on March 17 to the Minister of Citizenship and Immigration asking him to prohibit Moshe Ya'alon from entering Canada pursuant to section 35 of the Immigration and Refugee Protection Act (IRPA), which renders individuals guilty of committing war crimes or crimes against humanity inadmissible for entry. Ya'alon has been invited by Beit Halochem to speak on March 22 at Beth Emeth Synagogue.

Canada has obligations, under several international conventions to which it is a party, to arrest and prosecute international criminals such as Moshe Ya'alon. In pursuance of some of these obligations Canada has enacted the Crimes Against Humanity and War Crimes Act 2000. Hence, the letter also requests, should Ya'alon nevertheless enter Canada, that the Attorney General or Deputy Attorney General commence proceedings under section 9(3) of the War Crimes Act to have him prosecuted for the offence of committing war crimes and crimes against humanity, contrary to section 6 of the War Crimes Act, chapter 24.

Moshe Ya'alon is guilty of committing war crimes and crimes against humanity, in his capacity as former Head of the Israeli Defense Force Intelligence Branch, on or about 18 April 1996 at Qana. Ya'alon is also guilty of committing war crimes and crimes against humanity, in his capacity as Chief of Staff of Israel Defense Forces, on or about 22 July 2002 at Gaza City.

Ya'alon is responsible for the 1996 attack in Qana that caused the death of over a hundred villagers and the injury of many others, including Fijian soldiers assigned to the United Nations. With respect to his actions in Qana, Ya'alon is facing a civil suit in the U.S. from persons directly or similarly affected from the attack and it is clear that the measures taken or approved by Ya'alon in 1996 are in breach of international law as well as the terms of the War Crimes Act in Canada.

Ya'alon is also responsible for the 2002 attack in Gaza City where a one tonne bomb was dropped on a residential neighbourhood killing 14 civilians, most of them children. With respect to his actions in Gaza City in 2002, the Yesh Gvul movement submitted a brief on September 30, 2003 listing Moshe Ya'alon as a war criminal for being one of four individuals responsible for the attack.

Amnesty International, B'Tselem, Human Rights Watch and United Nations organs

have reported incidences in which the Israeli government committed war crimes or crimes against humanity with respect to combatants as well as civilians. The documents attached and referred to in the letter include 32 pages of reports from government and non-governmental organizations, as well as reports published in the International media.

ISRAELI WAR CRIMINAL VISIT TO TORONTO SPARKS OUTRAGE AMONG COMMUNITY GROUPS

20 March 2006

WHAT: Protest and Legal Action Against Israeli War-Criminal Moshe Ya'alon
WHEN: 7:30 pm, Wednesday March 22, 2006
WHERE: Beth Emeth Synagogue - 100 Elder Street

TORONTO - On March 22, Moshe Ya'alon, former Chief of Staff of the Israeli military, from 2002 to 2005, will be coming to Toronto. Ya'alon oversaw a number of massacres during his long military career and has openly expressed his racist disdain for Palestinians.

Moshe Ya'alon is guilty of committing war crimes and crimes against humanity, in his capacity as former Head of the Israeli Defense Force Intelligence Branch, on or about 18 April 1996 at Qana, South Lebanon. Ya'alon is also guilty of committing war crimes and crimes against humanity, in his capacity as Chief of Staff of the Israeli Defense Forces, on or about 22 July 2002 at Gaza City.

He told the Haaretz Newspaper on 27 August 2002, that "the Palestinian threat harbours cancer-like attributes that have to be severed. There are all kinds of solutions to cancer. Some say it's necessary to amputate organs but at the moment I am applying chemotherapy."

In response, the Coalition Against Israeli Apartheid (CAIA), a broad-based coalition of community and faith-based groups, is calling on friends and allies to mobilize and voice their opposition to the invitation of this racist war-criminal.

"It is absolutely unconscionable that the new Conservative government would allow a war-criminal of this stature to address an audience in Canada," stated Khaled Muammar, a spokesperson for the Coalition. "Ya'alon no longer enjoys immunity, he is liable for war-crimes prosecutions under Canadian law and this is exactly what the government should be preparing."

Allies of CAIA have launched a legal challenge to block Ya'alon's entry into Canada, on the grounds that his actions as Chief of Staff of the Israeli military constitute war-crimes.

It should be noted that Ya'alon is already being investigated for war-crimes in the UK and is the subject of a civil suit in the United States. He is liable for prosecution under Canada's Crimes Against Humanity and War Crimes Act (2000, c. 24).

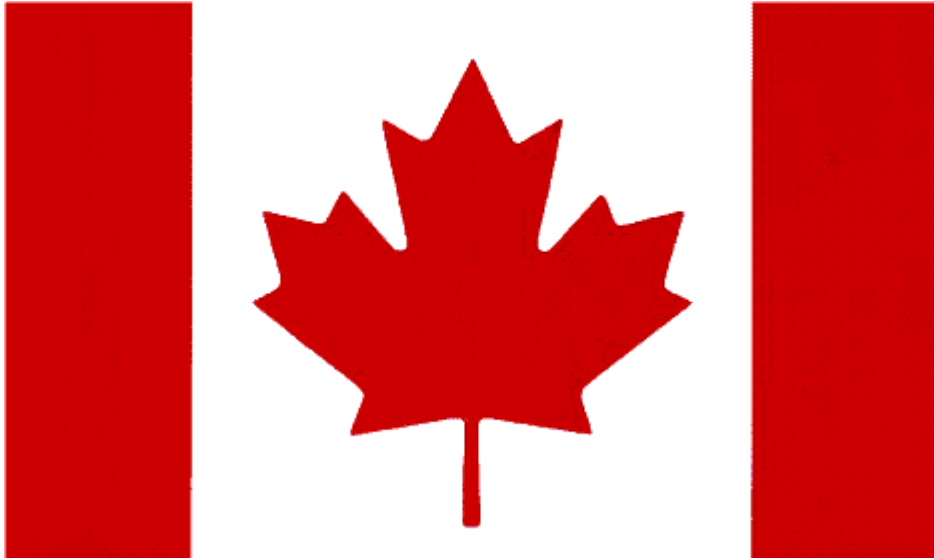
