Media And Top Officials Still Covering-Up Vince Foster 1993 Murder

U.S. Attorney Miguel Rodriguez claims Kenneth Starr and Brett Kavanaugh, assistant to the President and slated for a federal appeals court appointment, were major players in the Foster murder cover-up. Justice, however, has never been served because the mainstream media has been complicit in the cover-up.

In a 1999 book collecting dust and shunned by big time publishers, a trio of authors present compelling and overwhelming evidence Vince Foster, deputy counsel to President Clinton, was murdered in a cover-up leading right to the doorstep of the White House.

Speculation has always lingered in the collective public mind, Clinton had Foster bumped-off on July 20, 1993. But the case fell in the 'government black hole' of unsolved murders for hire, as the compromised judiciary turned a blind eye to the evidence, corruptly sanctioning the propaganda-based mainstream media story that Foster took his own life.

The book, entitled Failure of the Public Trust, doesn't delve into the motive behind the Foster murder, but presents shocking evidence, establishing beyond a reasonable doubt Foster was murdered, as well as documenting how the evidence was systematically covered-up by the corrupt Washington political machine, essentially allowing high-level politicians to get away with murder.

The book also serves another important purpose as the 511 page document contains an official legal document of evidence actually filed in six courts, including three US District courts in the District of Columbia, the US District Court for Eastern District of Virginia, the US Court of Appeals for the D.C. Circuit, the DC Circuit's Special Division for the Purpose of Appointing Independent Counsels, and the United States Supreme Court.

Even though evidence compiled by the authors proved beyond a reasonable doubt Foster was murdered, crime scene evidence was tampered with and grand jury intimidation took place, all the judges in the courts chose to ignore their findings.

Although Failure of the Public Trust is filled with crime scene irregularities pointing to a massive cover-up creeping into the halls of the White House, the most compelling parts of the book include the tape recorded testimony of U.S. Attorney Miguel Rodriguez's first hand knowledge of a cover-up, White House Counsel Brett Kavanaugh's involvement in the cover-up and co-author and grand jury witness of the Foster incident, Patrick Knowlton's, subsequent filing of 42 USC Sec 1985(2) civil rights law suit related to harassment he received before appearing before the Whitewater grand jury.

"The federal investigative records in our book and on our web site at www.fbicover-up.com prove the existence of an FBI / Independent Counsel / Media cover-up of the murder of deputy White House counsel Vincent Foster," said co-author Hugh Turley.

"We have been told that Foster's death has been thoroughly investigated by our government and media. They have lied to the public. Three federal judges attached evidence of the murder to Independent Counsel Kenneth Starr's Report on Foster's death, forcing Starr to include 20

pages from our findings showing he was killed.

"However, Starr's lead investigator, Assistant U.S. Attorney Miquel Rodriguez, admits in taped telephone conversations, included on our web site that Robert Fiske and Kenneth Starr's office covered-up the murder. Justice, however, has never been served since the media was informed and remains silent, keeping the American people unaware of what really happened."

In fact, Turley emphasized Thursday on Greg Szymanski's radio show, The Investigative Journal, the government cover-up of the Foster murder would have never succeeded but for the media cover-up and a total black out of what was really going on behind the scenes of the case.

Turley said that Rodriguez sent his statements and a copy of a sensitive internal White House tape recording to over 100 top journalists, showing Kavanaugh and other top White House officials complicit in the Foster cover-up.

"Nobody from any of the major outlets, including Ted Koppel and all the other top reporters ever talked about Rodriguez's statements or the fact Starr covered-up the 20 pages from our findings forced to be included his report by a federal judge," said Turley, adding that even today the total black out on these facts are being kept from the American people by a corrupt media.

"And what's even worse is that the people who covered it up are still in Washington. Most of them being rewarded with higher positions. For example, Kavanaugh is now an assistant to the President and is being nominated to the federal Court of Appeals for the District of Columbia.

"Simply, the people who covered up the Foster crime have been rewarded while those who told the truth like Rodriguez were either discredited or sent to lower level positions far away from Washington D.C."

It appears clearly the American press was involved in the Foster cover-up as verified by Rodriguez's own admission when he said:

"I have talked to a number of people that - you know, from Time Magazine, Newsweek, Nightline, the New York Times, Boston Globe, the Atlanta whatever, you know there have been well over a hundred, and this - this matter is so sealed tight, and, the reporters are all genuinely interested but when they start to get excited and they've got a story and they're ready to go, the editors - and they - I've gotten calls back, I've gotten calls back from all kinds of magazines worldwide, what the hell's wrong, why can't, you know, you were telling me that you, you didn't think this would go anywhere and sure enough I wrote the stories.

"They went to all the trouble of writing, and then it got killed. Again I spent almost eleven hours the New York Times and I know that they won't do anything about it and I do know that, that many people have called me back. Reporters that I've spent a lot of time with called me back and said the editors won't allow it to go."

Regarding the importance of the Foster cover-up even 13 years after the fact, author Turley said to "look at the bigger picture and proof of foul play and cover-up in this case is proof that our constitutional system of checks and balances failed in this case - the executive branch failed, the legislative branch failed, and the news media failed."

Continuing to emphasize the importance of this case in taking back our country from criminals while restoring our Republic's integrity, he added:

"Proof of cover-up is proof that we cannot rely on our separate democratic institutions to protect us from government corruption, as our Founding Fathers envisioned. Perhaps most importantly, proof of cover-up is proof that we cannot rely on the news media to keep government honest.

"The American public can demand better, but not without the proof of what it is we have been getting. The court filing on this site provides that proof. We can't rely on the very democratic institutions that have failed us to tell us of their failures. Public knowledge of this state of

affairs would give us the ammunition we need to improve the health of our democracy.

"We cannot fix what we don't know is broken. So, the existence of the cover-up in this case being widely known is important to us all. It's essential that the American people learn the truth. That's why we're asking for your help in getting the truth out to the American people - to improve the quality of our government and news media."

Although motive was never addressed by the authors, recent developments on Foster's whereabouts only days before his death, reveal he was in Switzerland on a White House assignment to collect \$250 million dollars from U.S. Treasury agent, Leo Wanta, instructed by the white House to give Foster the money for funds to be deposited in the Childrens' Fund chaired by Hillary Clinton.

After Foster returned to Washington with the money, Wanta was suspiciously jailed for 134 days in a Swiss dungeon for no apparent legal reason while the whereabouts or the use of the money has never been revealed.

Although Wanta and Foster both thought the money was to be used for a good cause, investigators later discovered a little known Presidential Executive Order transformed the Childrens' Fund into a CIA front company and was said to be used by the First Lady as her own slush fund.

It's also interesting to note Foster's Switzerland trip and any relationship between the vast sum of money and his death were never made a part of Starr's official investigation.

Recently, Wanta commenting on the Foster case, said he felt he was murdered, adding Foster told him he was about to testify against Clinton, important facts Starr should have been concerned about if an honest search for the truth was his goal.

Finally, in response to the question since there is a cover-up, why witnesses haven't come forward with the truth, Turley said:

"Someone did. Several witnesses who were at Fort Marcy Park reported that Mr. Foster's car was not in the Fort Marcy lot when Mr. Foster was already dead. Others, when showed the photographs of Mr. Foster's body at the park, reported that the crime scene had been tampered with.

"We don't know how many witnesses, besides Patrick Knowlton and those whose accounts appear in the public record, may have come forward. Additionally, put yourself in the position of a witness who has some information regarding the crime or its cover-up. To whom would you go? The FBI? The news media? The Congress? There is just no one to come forward to."
