Celebrated 'Liberté' increasingly meaningless in Jewish-supremacist state

LYONS - George Theil, a former elected representative and National Front member, will have to pay 10,000 euros and spend the next six months behind bars after the Lyons court of appeals upheld his initial sentence after he was convicted of "contestation of crimes against humanity".

Mr. Theil is the first person to be sentenced to prison under the Gayssot Act of 1990, which forbids "contestation of crimes against humanity,"--"humanity" in this case being a euphemism for Jews, for whose exclusive benefit the law was enacted.

The Gayssot Act has never been used for any other purpose than to persecute skeptics of Holocaust stories. At the same time, pointing out Jewish crimes against White humanity is a punishable offense in France.

Theil, a former member of the Rhône-Alpes regional governing council, disputed the existence of homicidal gas chambers at German wartime concentration camps during an interview with a local TV station in 2004.

"In my opinion, belief in the gas chambers shows blind admiration for German ingenuity. The more Zyklon B the Germans used, the more lives they saved, because Zyklon B is a disinfectant," Theil said.

Mr. Theil was convicted of similar "speech crimes" in 2001 and 2005 by courts in Grenoble and Limoges.

Six mois de prison ferme pour un ancien élu FN

LYON - La cour d'appel de Lyon a confirmé la condamnation à six mois de prison ferme et 10.000 euros d'amende d'un ancien élu du Front national, Georges Theil, poursuivi pour "contestation de crime contre l'humanité".

Depuis l'instauration en 1990 de la loi Gayssot réprimant le délit de contestation de crime contre l'humanité, Georges Theil, qui n'était pas présent à l'audience, est la première personne à être condamnée à une peine de prison ferme.


Les faits incriminés remontent au 14 octobre 2004.

Cet ancien conseiller régional de Rhône-Alpes, qui siégeait dans le groupe de Bruno Gollnisch avant d'occuper le poste d'attaché du groupe FN au Conseil régional, avait nié l'existence des chambres à gaz dans une interview à la presse écrite et à une télévision locale.

"A mon avis, la croyance aux chambres à gaz, c'est une admiration sans bornes pour la technique allemande", avait-il déclaré. "Plus les Allemands utilisaient le Zyklon B, plus ils sauvaient des vies, puisque le Zyklon B est un désinfectant."



Le 7 octobre 2005, Georges Theil avait déjà été condamné par le tribunal correctionnel de Limoges pour des propos similaires. Le 26 septembre 2001, la cour d'appel de Grenoble l'avait condamné pour les mêmes motifs.
