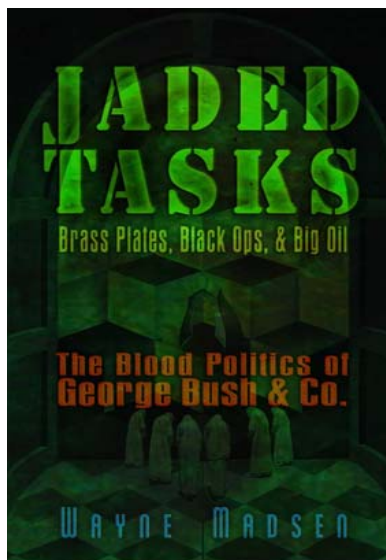

Aug. 21, 2006 -- WMR is currently on the road in northeastern Europe (the Baltic region). Early next week, the editor will be in the south-central Baltic region.

Aug. 21, 2006 -- More neo-con malfeasance surfaces in Europe -- three "suicides" getting another look and ransacking of a Socialist presidential candidate's home point to more Bush administration and neo-con dirty tricks.

As the Bush-Cheney administration gears up for a planned military attack on Iran, there is renewed interest by European intelligence analysts in the July 17, 2003 reported "suicide" of British Ministry of Defense weapons of mass destruction (WMD) specialist and UN Iraq weapons inspector Dr. David Kelly. In what is widely believed to have been a Blair government cover-up, Lord Hutton, in his official report, concluded that Kelly committed suicide in a wooded area near his Oxfordshire home using a dull knife to cut his left wrist and ingesting 29 over-the-counter analgesic tablets.

With the Bush administration now using the Iraq playbook to justify an attack on Iran, Kelly's knowledge about the disappearance of two South African nuclear-tipped missiles from a U.S. B-52 that crashed in the Indian Ocean in February 1991 may have sealed the British scientist's fate. The two tactical nuclear weapons, being shipped to the United States for de-arming after South Africa's majority government scrapped the nation's nuclear weapons arsenal, created by the apartheid government with the technical assistance of Israel, were lost after a U.S. Air Force B-52 carrying them from the Indian Ocean island of Diego Garcia to the United States crashed as a result of multi-engine failure off the Somali coast. The plane has developed electrical problems after leaving Diego Garcia and was attempting a return to the island with its sensitive cargo. Three crew members of the B-52 parachuted to safety but three others were killed when the plane crashed into shallow waters off the Somali coast.

Kelly was a British security services asset who knew about the South African nuclear weapons program. He was also aware that a neo-con disinformation story that the two South Africans tactical nukes were retrieved by weapons dealers, sent to Oman, and sold to Iran for the cannibalization of their weapons-grade uranium was false. In fact, Kelly knew that then-Secretary of Defense Dick Cheney was well aware of the loss and subsequent retrieval of the nuclear weapons by covert U.S. intelligence assets but failed to warn the United Nations pursuant to the Nuclear Non-Proliferation Treaty (NPT) as required under U.S. law. The United States was a party to the NPT at the time of the "loss" of the South African weapons. Moreover, all of the countries reported to have been involved in the weapons shipment -- South Africa, Oman, and Somalia -- were also parties to the NPT. It is feared that the weapons-grade uranium from the South African nukes will be used as a "smoking gun" to show Iran's possession of nuclear weapons -- perhaps in a dirty bomb "found" entering Lebanon to Hezbollah forces from Syria. Such an event would give the neo-cons justification for simultaneous attacks on Hezbollah, Syria, and Iran.

There is also renewed interest in the reported "suicides" of two telecommunications experts

who discovered U.S. intelligence involvement in the tapping of European cell phone communications. On February 4, 2006, WMR reported, "A sophisticated cellular phone eavesdropping system has been discovered in Greece. The surveillance system was placed within the Vodafone cellular phone system and apparently used a trap door in a 'locked field' contained in Ericsson phones creating a virtual 'sub system' within the cellular system. Among those being wiretapped by the surveillance system reported to have been installed by highly-proficient IT professionals was Greek Prime Minister Costas Karamanlis, the Greek Foreign Minister and the Commissioner to the European Union, Greek national security officials (Defense, Public Order, and Justice Ministers), opposition leaders, journalists, peace activists, and Arab nationals. The cell calls were relayed to an antenna array in the vicinity of the U.S. Embassy in Athens."

It was later discovered by the Greek government that the antenna relay near the U.S. Embassy re-transmitted the intercepted cell phone signals to Laurel, Maryland, quite possibly a super-secret joint National Security Agency/CIA activity known as the Special Collection Service (SCS) or "F6," located in a non-descript office complex between Laurel and Beltsville, Maryland. The SCS specializes in the type of "black bag" eavesdropping operation that was directed against the Greek government and Greek private citizens. For its communications, the SCS piggybacks on the satellite network run by the U.S. State Department's Diplomatic Telecommunications Service (SA-26), located adjacent to the SCS building in Beltsville.

On March 9, 2005, Costas Tsalikidis, the Vodafone telecommunications expert who discovered the U.S. eavesdropping system in Athens in early 2005, was found by his mother

hanging from a rope in his apartment. There was no suicide note.

On February 17, 2003, a special CIA and SISMI Italian intelligence team kidnapped Imam Hassan Mustafa Osama Nasr from a Milan street and shipped him secretly to Egypt for imprisonment and torture. Adamo Bove, the telecommunications security chief for Telecom Italia, identified from their cell phone call records, 26 CIA agents now wanted by Italian authorities for kidnapping the imam. Bove was assisting the Italian authorities in their investigation of the American team. On July 21, 2006, Bove's body was found below a Naples highway overpass, his car parked on the bridge above. Police ruled Bove's death a suicide.

After returning from their August holiday, French Socialist presidential candidate Ségolène Royal and her partner, French Socialist Party Secretary General Francois Hollande, discovered that their Paris apartment had been broken into and ransacked. Although nothing was stolen, Royal and Hollande reported the break-in to police. Royal also suspects that wiretaps were placed on her phone lines. After reporting the break-in, Interior Minister Nicolas Sarkozy, France's leading neo-con and candidate for the right-wing UMP party in next year's presidential election, leaked the break-in story to the press, angering Royal and Hollande.

Sarkozy has been under investigation for accepting bribes while French Budget Minister from 1993 to 1995 in a Taiwan frigate scandal that involved a series of secret accounts at Cedel International (later Clearstream Banking SA) in Luxembourg. An examination of an internal Clearstream document by WMR reveals a number of Taiwan-French accounts (BNP Paribas Taiwan Branch, Societe Generale SA Taipei Branch, Credit Lyonnais Taipei Overseas Banking Unit, etc.) held in the Luxembourg-based banking clearing house. Joel Bucher, the one-time deputy director of Societe Generale's Taipei branch, in a letter to Luxembourg prosecutor Carlos Zeyen, confirmed that his bank branch used the Clearstream accounts for paying bribes and laundering money. Some of the bribes were paid through Cedel International, which merged in 2000 with Deutsche Borse Clearing to create Clearstream.

Not only have the Socialists demanded a full investigation of the scandal but former French DGSE Secret Service General Philippe Rondot has revealed that it was President Jacques Chirac and Prime Minister Dominique de Villepin who ordered the secret services investigation of Sarkozy's financial involvement in the scandal. WMR's French sources report that Chirac, de Villepin, and the Socialists suspect Sarkozy of links, through Clearstream, to individuals connected to the Russian-Israeli Mafia. Sarkozy, who is strongly pro-Israel, is a hero to the global neo-con network, having helped egged on a number of Muslim riots in France last year by his use of anti-immigrant racial and religious rhetoric.

Sarkozy continues to bring neo-con dirty politics to France.

A number of Clearstream accounts involved in the Taiwan frigates pay-off deal were linked to convicted Russian oligarch mobster Mikhail Khodorkovsky, his Bank Menatep, and French political beneficiaries of Clearstream money flows. Other Clearstream money flows reportedly involved Colombian drug cartels, multinational oil companies, Banco Ambrosiano, CIA money laundering, the Italian P-2 Masonic lodge, and the Vatican Bank. As Interior Minister, Sarkozy is in the perfect position to determine what evidence his political opponents and investigating judges like Renaud Van Ruymbeke have on him.

It is clear that Europeans are growing tired and hostile as a result of Bush administration and neo-con activities throughout the European Union.

Aug. 21, 2006 -- William Black, the Deputy Director of the National Security Agency who was hauled out of retirement by then-NSA Director (current CIA Director) Gen. Michael Hayden in a move that was unpopular with the NSA's rank and file, has been replaced by John C. Inglis.

For the past three years, Inglis has served as the Senior U.S. Liaison Officer in London and was the chief link between Britain's Government Communications Headquarters (GCHQ) and NSA. In that position, where he would have helped oversee NSA's operations at the agency's massive Menwith Hill listening station, Inglis would have been aware of all of NSA's covert communications intercept programs in Europe, including the operation in Greece referenced in the article above. And in what is clearly a warning that NSA's priorities against North Korea and China may be heightened, Inglis once served as the chief of the NSA's Office of China and Korea in the Signals Intelligence Directorate.

What is not well known is that like Hayden, Inglis is a U.S. Air Force general. Inglis is a Brigadier General in the Maryland Air National Guard and serves as Chief of Staff. His duties include representing Maryland Governor Bob Ehrlich on matters affecting the Maryland Air Guard. The militarization of the NSA Deputy Director position is a further indication that America's chief eavesdropping agency is becoming a political weapon for the Pentagon neo-cons and the White House.

Aug. 19/20, 2006 -- Additional clues point to U.S. attack on Iran. State Department sources report that State's Iran Desk Officer Henry Wooster has suddenly been transferred to another position. Meanwhile, Vice President Dick Cheney's office is assembling a group of neo-cons from the Pentagon, State Department, and the National Security Council to cook up intelligence and talking points that will show Iran to be an imminent nuclear threat.

Aug. 19/20, 2006 -- Personal data thefts continue unabated. The most recent thefts of personal data have been from the medical community. A regional office of Hospital Corporation of America (HCA), the firm in which Tennessee GOP Senator Bill First has a major financial interest, has reported the theft of 10 computers containing "thousands of files" on Medicare and Medicaid patients and their doctors. The time frame of the data is 1996 to 2006 and the files contain Social Security Numbers and dates of birth on individuals in Colorado, Kansas, Louisiana, Mississippi, Oklahoma, Oregon, Texas, and Washington. The California Department of Mental Health reports the theft of a computer tape containing the Social Security Numbers and dates of birth of 9,468 employees.

Aug. 18, 2006 -- African uranium redux. The neo-cons are re-using their Iraq War playbook. In this case it is Iran, not Iraq, supposedly purchasing uranium from Africa, not from Niger, but from Congo.

On Aug. 6, 2006, Rupert Murdoch's main British mouthpiece, *The Sunday Times*, reported that "Iran is seeking to import large consignments of uranium from Africa." It was a similar

utterance, contained in a bogus 16-word claim by George W. Bush in his 2003 State of the Union address that was used, in part, to justify America's and Britain's disastrous invasion and occupation of Iraq. Now, the same canard is being used to justify a U.S. attack on Iran. *The Sunday Times* chief source for its story was an unnamed Tanzanian customs official who claimed that Tanzanian customs intercepted in October 2005 an air shipment of uranium from near Lubumbashi in Congo's Katanga to Mwanza in Tanzania. The alleged uranium shipments from Congo to Iran were said to have started in 2002 and consisted of several alleged shipments. The alleged source of the uranium, the Shinkolobwe mine in Katanga, was also the source for the uranium used in the U.S., atomic bombs dropped on Hiroshima and Nagasaki.

The only problem with the *Sunday Times* story is that the Shinkolobwe mine is no longer in operation. "The Congo mine has been closed for decades," according to a very knowledgeable U.S. government source who has dealt extensively with African uranium production. Congo's government claims the ore concentrator for Shinkolobwe has been shut down since 1961 and, therefore, cannot be concentrated into refined yellowcake uranium.



Latest neo-con "Big Lie": Congo's Shinkolobwe mine, which has not produced yellowcake uranium since 1961, is selling the refined uranium ore to Iran via a clandestine jungle network worthy of a Frederick Forsythe novel.

Resource-rich Congo, which is just emerging from a genocidal civil war encouraged by U.S., British, and Israeli elements using their surrogates in Rwanda, Uganda, and eastern Congo, is a lucrative target for the Bush administration and its criminal accomplices. Conveniently for the neo-cons, the story about Congolese uranium shipments to Iran is said to have involved trans-shipment points in Sudan and Syria and middlemen in Lebanon, all three countries targets of the Project for the New American Century operatives in Washington, London, and Jerusalem/Tel Aviv. Currently, the CIA, under the regime of General Michael Hayden, is cooking the intelligence to prove the Congolese-Tanzanian-Sudanese-Syrian-Iranian uranium



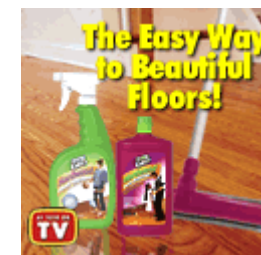
smuggling connections. Just for good measure, the neo-cons are suggesting that Zimbabwe, a major target of the Bush administration, and Zambia, were also involved in the alleged elaborate uranium smuggling scheme. President George W. Bush is reported to have ordered Hayden and National Intelligence Director John Negroponte to do everything possible to prove a uranium connection between Iran and Congo.

Africa, which is rife with false "official looking" documents, such as those Nigerien documents laundered through the Silvio Berlusconi-Italian Fascist-Michael Ledeen network to "prove" that Saddam Hussein was trying to buy yellowcake uranium from Niger, is a favorite place for the neo-cons to cook up phony intelligence and false flags. Some of the phony intelligence being used to prove a Congolese-Iranian uranium link is originating with political enemies of President Joseph Kabila, who is the reported winner of the recent UN-supervised presidential election. His two major opponents, both U.S. and Israeli-backed guerrilla leaders, are the likely sources of the bogus uranium stories. Belgian intelligence, which has extensive sources in Kinshasa and throughout Congo, have scoffed at the reports of the alleged uranium sales. They have evaluated the uranium reports with a confidence level of "not serious," according to the Belgian magazine *Trends*. The Belgian magazine also reports that an official of the American embassy in Kinshasa visited the Shinkolobwe mine on August 9 and "found nothing irregular." The International Atomic Energy Agency (IAEA) in Vienna has also derided the notion of Congolese uranium sales to Iran.

Trends also discovered some proof that official Congolese Gécamines (the Congolese state mining company) uranium sales records from 1966 to 1968 were tampered with to make it look like there were recent sales of uranium from Katanga to Iran. The magazine states, "The serial numbers of the uranium shipments referred to in the exchange of letters between Wieland GmbH [of Germany] and Saman Cheshemen [mining company] of Iran, could possibly been taken from official uranium sales by the Congolese state-owned company Gécamines of existing reserves from 1966 and 1968 from Shinkolobwe. Have those previous serial numbers been used to give this smuggling operation an appearance of truthfulness? The incredible amount of 2 billion dollars is explained by some as forming part of a money laundering operation." As every user of e-mail is aware, Africa is the source for all kinds of money laundering schemes and frauds. It would seem that the neo-cons are the only people in the world not aware of these schemes but are, nevertheless, trying to convince professional intelligence agencies that the money laundering operations and phony intelligence reports are clues in proving a "Congo sells uranium to Iran" scheme.

A U.S. intelligence source told WMR two months ago that the Kabila government would be implicated by the neo-cons in a false uranium smuggling operation with Iran in an effort to justify both an attack on Iran and a military overthrow of Kabila by pro-U.S./Israeli elements in Congo. Kabila has been the target of several attempted coups staged in neighboring countries by mercenaries in the pay of U.S. and British intelligence. It now appears that the forecast of a phony Congolese link to uranium sales, which also mentioned Tanzanian involvement, was correct. It is also very apparent that the neo-cons are becoming incredibly predictable in their machinations. As with Niger and the bogus yellowcake sales to Iraq, we now have forged Congolese documents, phony news stories emanating from the always-suspect Murdoch News Corp. falsehood factory, and intelligence agencies calling the bluff of the neo-cons.

Aug. 18, 2006 -- Two recent events appear to be connected to WMR's Aug. 14 story on how NewsCorp's Rupert Murdoch conspired with Tony Blair and the Bush administration to cook up the "London liquid bomber" plot in an effort to shore up Blair's and Bush's sagging poll numbers. On our report on how the phony scare was cooked up by Murdoch and Blair to prevent a midnight coup against Blair by his Labor opponents working with Prince Charles, it has now been reported that Deputy Prime Minister John Prescott, passed over by Blair in favor of Home Secretary John Reid to handle the Cabinet meetings in Blair's absence, said



President Bush had been "crap" on the Middle East peace process and described him as a "cowboy."

Predictably, the Murdoch-influenced neo-con media, particularly Mr. Hispaniola Weird Sex himself, Rush Limbaugh, wasted no time in calling Prescott a "drunk," "slob," "union hack," "pig," and a "womanizer."

Since WMR's scoop on the events that precipitated the phony liquid bomber scare, the group of Labor officials who were in on the anti-Blair coup is widening to include some previous Blair loyalists. International Development Secretary Hilary Benn, the son of veteran Labor Party progressive leftist Tony Benn, and a strong Blair supporter, was part of the anti-Blair movement, along with another Blair loyalist, Environment Secretary David Miliband; Blair's former aide Bruce Grocott; and Transport Secretary Douglas Alexander, who was vacationing on the Isle of Mull as the airplane scare plot was being hatched by Blair's and Murdoch's operatives. Alexander, with primary responsibility for air travel in Britain, was one of the last to be informed about the "threat," a decision taken by Blair's inner circle of neo-cons, including Home Secretary Reid, a one-time Communist student leader and campus agent provocateur.



British Deputy Prime Minister John Prescott, a major player in the aborted midnight coup against Tony Blair, calls Bush's policies "crap." Prescott called a "slob" by neo-con drug-addled pig face Rush Limbaugh.

The other clue that Murdoch's media empire is more into making up news rather than reporting it -- a situation covered recently in depth by WMR -- is the sudden resignation of Fox News's Amman, Jordan bureau. Two producers based in Amman for Fox -- Serene Saddagh and Jomana Karadsheh -- resigned in protest over how the so-called "news" network was covering the Middle East crisis. They both accused Fox of being propaganda organs for the Israeli government and its Bush administration facilitators.

Aug. 18, 2006 -- The Ku Klux Klan, neo-Nazis, and Republican Party. As the GOP continues to crash dive in the opinion polls, Republicans are becoming more and more desperate. We now have word that S.R. Sidarth, the Jim Webb campaign worker who was called a "macaca" (monkey) by Virginia Republican Sen. George Allen at a mini-Klan rally/Allen campaign stop in a hamlet near the Virginia-Kentucky border, is the great grandson of the secretary for Mohandas "Mahatma" Gandhi, the famous preacher of reform through political non-violence.

A very underfunded and practically resource-less group of independent investigative journalists have exposed the true base of the Republican Party and its criminal enterprises. In the Deep South of Alabama and Florida, our colleague, investigative journalist John Caylor, at much risk to himself and his family, has exposed the dealings of what he terms the "Dixie Mafia." In northern Virginia, John Edward Hurley, a colleague of the late long-serving White House correspondent Sarah McClendon, has investigated what is known as the "neo-Confederates." Both Caylor and Hurley have carried on their respective investigations since the 1980s and the Reagan-Bush I administration.

When this editor states that these two journalists have conducted their investigations at much risk to themselves is not literary license. Caylor, who ties the Florida and Alabama GOPs to drug dealing and murders going back to the days of Barry Seal and cocaine smuggling for George H. W. Bush's Iran-Contra scheme, has recently seen his 78-year old mother bludgeoned to death by unknown assailants. The Alabama Bureau of Investigation's response to Caylor in his time of distress: "99.99 percent of what you have on your web site [www.insider-magazine.com] is pure bullshit." In the Dixie Mafia's world, racists tied to the Klan and Aryan Nations supplement their income by running drugs and engaging in contract murders for their political and crime bosses. Their activities have been the focus of Caylor's print and Internet publications.

Caylor was recently arrested and roughed up by Bay County, Florida sheriffs when he attempted to use Florida's open government sunshine law to obtain records implicating some of Jeb Bush's most important allies, including Florida GOP House Speaker Allan Bense, in criminal activity. Caylor now faces a trial orchestrated by Jeb Bush's thugs in Tallahassee. Florida is a hotbed for the racist GOP. Tramm Hudson, the GOP candidate who is running for the 13th congressional district seat occupied by Katherine Harris, recently told a Christian Coalition forum that "blacks aren't the best swimmers or may not even know how to swim."

The abuse encountered by Hurley, while not as violent as that experienced by Caylor, was also coordinated and aimed at destroying another independent journalist. Hurley, his wife, his medical doctor brother, and his colleague Sarah McClendon, were all frivolously sued by neo-confederates who are all top GOP operatives, some of whom are tied to the Aryan Nations and Ku Klux Klan. Hurley, whose Confederate Memorial Association and downtown DC museum and hall constituted an attempt to pay tribute his and colleagues' families' pasts in the Washington, DC area in the antebellum, Civil War, and post-Civil War era, was confronted by GOP neo-Confederates who want to use every Confederate memorial shrine and memorial in the mid-Atlantic region as rallying points for the KKK, white supremacists, and right-wing fundraisers. When Hurley denied the neo-Confederates the use of the Confederate Memorial Hall in Washington for Iran-Contra fundraising events he and his family became immediate targets. Hurley would face "bought-and-paid-for" corrupt judges, like DC Judge John H. Bayly, Jr., who would slap him with fines, judgments, and as what happened to Caylor in Florida, even time in prison. Hurley, like Caylor, has been physically assaulted. [See Hurley's collection of documents and articles at <http://www.confederate.org/publish/legal/legal.html>].

Journalists like Caylor and Hurley are a rare and endangered species in Bush's America. Journalists who cannot be threatened through their corporate chains of command are intimidated in other ways -- in Caylor's case with brutal police methods and the murder of his

mother. With Hurley, it was financial ruination by corrupt right-wing attorneys and judges. Caylor and Hurley and a small band of investigate journalists are trying to keep the First Amendment right of a free press alive in a country where major infotainment media conglomerates like News Corp make up the news and accentuate propaganda from the White House, neo-con think tanks, and corporations.

Aug. 18, 2006 -- The covert program to steal personal data on Americans to populate a highly



secretive NSA/Homeland Security Total Information Awareness surveillance database continues at a frenetic pace. The FBI, under orders to leave these thefts alone, sits idly by as more and more data is stolen from government agencies and corporations. The San Francisco Bay Area has been particularly hard hit in the latest rash of personal data thefts.

The latest victim is Chevron of San Ramon, California which has reported the theft of a laptop computer from an independent auditor that potentially contains "tens of thousands" of files on Chevron employees' retirement, savings, and disability programs. Included in the data are Social Security Numbers, dates of birth, and sensitive financial information. "U.S. payroll employees of the firm are affected and they number approximately 29,000. San Francisco-based William-Sonoma said an employee of Deloitte-Touche had a laptop computer stolen in Los Angeles that contained the financial information and Social Security Numbers of 1200 Williams-Sonoma employees. Kaiser Permanente in Oakland reported a laptop stolen that contained medical record numbers and dates of birth of 160,000 Kaiser patients.

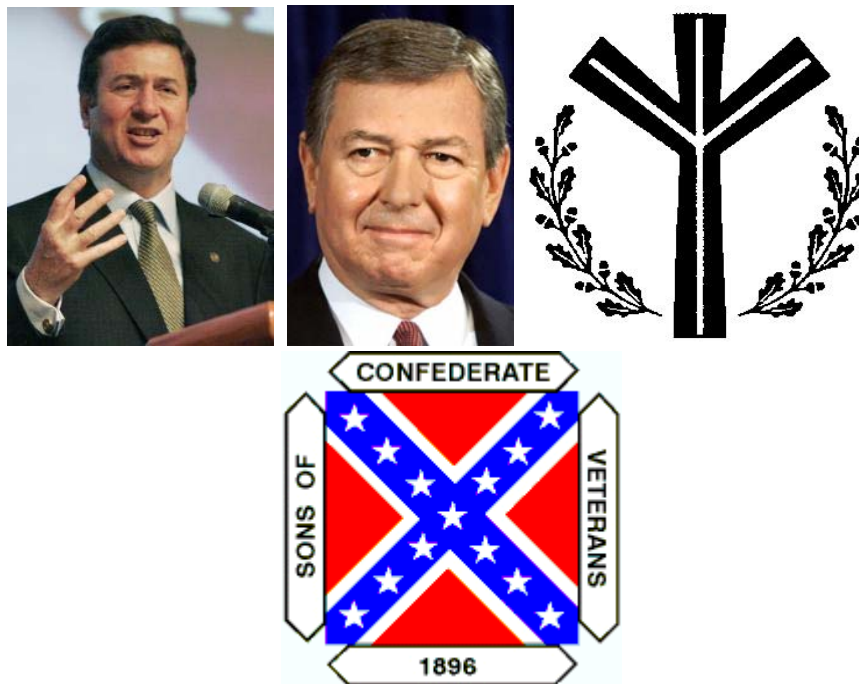
Aug. 17, 2006 -- EXCLUSIVE. WMR has uncovered evidence that the Bush administration is riddled with individuals who not only advocate for the Confederacy but are also linked with leaders of the racist Aryan Nation Brotherhood. With the recent focus on Virginia Senator George Allen's racist comment about a South Asian-American working for Democratic candidate Jim Webb's campaign (Allen called the campaign worker a "macaca" (a monkey) -- a French-language racist term for people with dark skin, an examination of the corporate filings of Jefferson Davis Camp #305 of the Sons of Confederate Veterans (SCV), which, according to Confederate Memorial Association director John Edward Hurley, has been a longtime hub for extreme right-wing Republican activities.

SCV 305's last non-profit corporation filing with the District of Columbia was on [January 10, 2006](#). The name of the registered agent is Charles Goolsby and the Director is listed as Richard T. Hines. Goolsby is a producer for the Voice of America who told *The Nation's* Max Blumenthal in [an August 16, 2005 article](#) that he had not been part of the SCV "in a long time." However, SCV 305's corporate filing clearly indicates that Goolsby was the registered agent for the group five months after his denial appeared in *The Nation*. Goolsby is in charge of issuing International Crime Alert for the VOA and the International Broadcasting Bureau. The criminal

alerts, while including global alerts on Osama Bin Laden and various Latin American narco-criminals, does not include any right-wing groups or terrorists.

Richard T. Hines, who owns RTH Consulting, is a top GOP lobbyist who is involved in various neo-Confederate activities, including the annual Confederate Memorial service in Arlington National Cemetery -- a ceremony that honors Jefferson Davis on his birthday and which brings together a "Who's Who" of neo-Confederate luminaries in Washington, DC. Hines' clients include Cambodia, Saudi Arabia, the military dictatorship of the Gambia, and the oil-rich Akwa-Ibom state in what partly constituted the former secessionist Republic of Biafra. Hines has also been a writer for the secessionist *Southern Partisan* magazine, in the pages of which are found the words of Trent Lott praising the principles of Jefferson Davis and how they apply to the Republican Party and John Ashcroft heaping praise on the Confederacy.

In the past, the Arlington Confederate memorial service has received wreaths from George Allen and his senatorial colleague John Warner. Allen is a longtime supporter of SCV activities, having, as Governor of Virginia, issued a 1994 proclamation, drafted by the SCV, that declared the month of April "Confederate History and Heritage Month." The proclamation lauded the Confederacy's four-year "struggle for independence." Hines, a native of South Carolina, was involved in the trashing of John McCain in that state's GOP primary on behalf of the Bush 2000 presidential campaign. Hines learned dirty and race baiting politics from a fellow South Carolinian Republican, the late Lee Atwater, the role model for Karl Rove.



Meet the other neo-cons -- the Neo-Confederates -- George Allen, John Ashcroft, the neo-Nazi National Alliance, and the Sons of Confederate Veterans Jefferson Davis Camp 305.

SCV 305's [corporate filing for 1996](#) also shows that a past director of the group was Jeffrey Addicott, a former Pentagon legal counsel for the Special Forces and now a professor at the St. Mary's University School of Law in San Antonio and Director of its Center for Terrorism Law. It was recently revealed that Addicott had received a \$1 million contract from the Air Force Research Laboratory in Rome, New York to research ways to limit the federal Freedom

of Information Act (FOIA) and various state FOIAs and sunshine acts. The money was earmarked in the defense authorization act by Texas Republican Senator John Cornyn, a graduate of Addicott's law school.

The 1996 filing also lists David Eno as Commander of SCV 305 (Eno also signed the filing). Eno works in the General Counsel's office at the National Credit Union Administration, the oversight body for credit unions in the United States. Hurley points out the ties between the neo-Confederates in a 2005 press release from his Confederate Memorial Association, which has been single handedly battling repeated attempts by the neo-Confederates to advance their right-wing and racist agendas at the expense of legitimate Confederate historical organizations:

[Now Chief Justice John] Roberts represented the National Credit Union Administration when he was with Hogan and Hartson. In 1997, Roberts argued the NCUA case before the Supreme Court, which dealt with expanding the banking market for credit unions. In that case, Robert M. Fenner was listed as counsel for the NCUA with Roberts. [The Confederate Memorial Association's John Edward] Hurley said that Fenner had employed David Eno as the head of his fraud hotline operation at NCUA. According to Hurley, Eno was a commander of the Jefferson Davis Camp No. 305 of the Sons of Confederate Veterans, an organization that sued the Confederate Memorial Association. Kirk Lyons, an attorney who has represented the Ku Klux Klan and the Aryan Nation, is an officer in the Sons of Confederate Veterans. Eno and Richard Hines, another commander of the Jefferson Davis Camp and the husband of White House Domestic Policy advisor Patricia Hines, were behind the litigation against the Confederate Memorial Association."

The most recent filing from 2006 also lists some other interesting players in SCV 305. They include Thomas Moore, a director. Moore, a graduate of The Citadel in South Carolina and a native South Carolinian, is listed as a consultant for American Business Development Group (A-BDG), a defense lobbying group, and the Washington agent for the Belgian company Fabrique Nationale Herstal (FN), described in his A-BDG resume as "the world's leading manufacturer of military small arms." Moore previously served as the director for defense studies at the right-wing Heritage Foundation and, from 1992 to 1995, worked as a staffer on the Senate Armed Services Committee where his portfolio mainly included issues dealing with the anti-ballistic missile defense system, the pet project of Donald Rumsfeld who headed the commission that urged a return to Star Wars defense systems. In fact, from 1988 to 1992, Moore served in the Reagan Defense Department where he acted as the Strategic Defense Initiative liaison to the Congress. FN Manufacturing's U.S. headquarters is located in Columbia, South Carolina.

Moore is also the author of a novel, *The Hunt for Confederate Gold*. The book is described by Amazon.com as "a mystery, a thriller. . . based on one of America's most intriguing unanswered questions: what happened to the Confederacy's gold in 1865? And what might be the consequences if it were recovered today and returned to its rightful owners? And just who are the rightful owners, the U.S. Government, claiming it as contraband of a hundred-and-forty-year-old rebellion; or the Southern people? *The Hunt for Confederate Gold* is written not just about the South, but for the South; not just by a Southerner, but for Southerners." In the book, a secretive neo-Confederate group is bent on recovering the Confederate gold -- its name is "The Fellowship," the same name used by a secretive right-wing Christian group based in Arlington, Virginia that sponsors the annual National Prayer Breakfast. The Fellowship of Arlington is also known as "The Family," which was the name used by a group of white supremacist arsonists who burned down several high-priced homes owned by African Americans in Charles County, Maryland. The Fellowship in Arlington, founded by a pro-Adolf Hitler Norwegian immigrant minister named Abraham Vereide, is an umbrella organization that combines a number of right-wing fundamentalist Christian groups.

An examination of [SCV 305's articles of incorporation](#), filed on July 21, 1993 with the District of Columbia, reveals among its [original seven directors](#) were, in addition to Goolsby, was Lewis Doherty, listed with the "Western Heritage Fund" located at 107 S. West Street, Suite 180, Alexandria, Virginia. Doherty is also listed, with Goolsby, as one of the [three incorporators](#). Doherty is now a key player with the neo-Nazi National Alliance, headquartered in Hillsboro, West Virginia. It is ironic that Goolsby, who tracks terrorists for the VOA, consorts with the likes of Doherty who represents a violent and terroristic neo-Nazi organization that served as a magnet for Oklahoma City Murrah Federal Building bomber Timothy McVeigh.

Another [original director](#) was Jim Manship, an Alexandria, Virginia historian who debunked the findings of a Monticello Foundation report that were based on DNA analysis that Thomas Jefferson fathered children with his slave Sally Hemings. Another of the seven founding directors is retired Army Colonel, Father Alister Anderson of the Greek Orthodox Church, who was a Chaplain-on-Chief of the Sons of Confederate Veterans as well as a U.S. Army Chaplain.

Aug. 17, 2006 -- Another Latin American country leaves the U.S. "reservation." Only two countries with diplomatic ties with Israel have located their embassies in Jerusalem -- Costa Rica, which moved its embassy from Tel Aviv to Jerusalem in 1982 amid much fanfare, and El Salvador. Costa Rica's Nobel Peace Prize winning President Oscar Sanchez Arias, much to the displeasure of the neo-cons in the Bush administration, has announced that Costa Rica's embassy will be moved back to Tel Aviv to "correct a historical mistake." Israel called Arias' move an "unfriendly act." With El Salvador, a virtual colony of the United States, being the only country with an embassy in Jerusalem, there will be a renewed effort by neo-cons in the Bush administration to move the U.S. embassy from Tel Aviv to Jerusalem.

Aug. 16, 2006 -- WMR has reported on the policy of the neo-cons in the Bush administration to destroy the effectiveness and influence of the United Nations. America's unconfirmed ambassador to the UN, John Bolton, his staff, working together with Israeli ambassador Dan Gillerman and his staff, have instituted a climate of fear among UN staff, diplomatic missions, and media. WMR has now learned that a similar situation exists at the Commonwealth headquarters in London. The motive of British neo-cons is to weaken the Commonwealth of

Nations, the last vestige of the British Empire, thus depriving the British monarchy of a major *raison d'être* and dealing another blow to Prince Charles, a bitter foe of Tony Blair and his neo-con "New Labor" policies.

The Commonwealth Secretary General, Don McKinnon of New Zealand, a London-born New Zealander and member of the right-wing National Party under which he served as Defense Minister and Foreign Minister, was singled out for criticism in a May 31 report by a Commonwealth Investigative Panel headed up by Glenda Morean Philip, Trinidad and Tobago's High Commissioner to the UK. The report stated that there is a "climate of fear in the Commonwealth Secretariat" and that people will not speak out because of a "fear of retribution." The language used in the Commonwealth report is similar to the words spoken on strict background by employees of the United Nations, U.S. Defense Department, Central Intelligence Agency, National Security Agency, State Department, and other international organizations and government departments.



Under neo-con Don McKinnon, Commonwealth turned into a "Yes Massa" club doing the bidding of the English-speaking white countries and their corporations and bankers.

The Commonwealth is composed of 53 member states that are mostly former British colonies in Africa and the Caribbean. The organization is headquartered in Marlborough House in Pall Mall in central London and the head of the Commonwealth is Queen Elizabeth. The situation in the Commonwealth Secretariat worsened in 2002 when Zimbabwe had its membership suspended, largely as a result of pressure from the Bush and Blair administrations, which were attempting to oust Zimbabwean President Robert Mugabe. One of the harshest critics of the Commonwealth under McKinnon is Professor Victor O. Ayeni of Nigeria, the Commonwealth's director of the Governance and Institutional Development Division. Since Zimbabwe's suspension, a number of black African and Caribbean staff members have detected a strong whiff of racism in the air at the Commonwealth.





The Commonwealth goes the way of the United Nations: Neo-cons are forcing a climate of fear and retribution -- "go along, get along, or be gone."


While the Commonwealth is used as an instrument to ensure the spread of neo-con policies in the English-speaking world, it is doing little to promote democracy. While kicking out Zimbabwe for its dictatorship, McKinnon has chosen Uganda as next year's site of the Commonwealth Heads of Government Meeting, thus rewarding that country's pro-American and pro-British dictator Yoweri Museveni. Museveni is a favorite of the neo-cons and their racist philosophies, having once blamed Africans themselves for slavery.

Aug. 16, 2006 -- Mercenaries, mercenaries, everywhere. The Bush administration continues to be a dream-come-true for mercenary firms. In just a little over a week, Blackwater USA received a \$7.1 million contract for personal security detail services in Baghdad. Interestingly, the contract is due to expire on September 30, 2008. Dyncorp received a contract to "re-train" the Sudan People's Liberation Army (SPLM/A) of the Sudan People's Liberation Movement into a "professional" fighting force. The SPLM/A is the southern Sudanese guerrilla force that signed a peace agreement with the Sudanese central government in Khartoum. Neighboring Uganda already serves as a hub for U.S. mercenary and CIA activity in central and eastern Africa. Large oil reserves have been discovered in areas under the control of the SPLM.

Aug. 16, 2006 -- From our National Press Club sources who cover the White House: the White House Press Corps was told that its move from the White House to "temporary" quarters in the New Executive Office Building across Pennsylvania Avenue (which is now more like Red Square than an avenue) is far from temporary. The Bush White House promised that renovations to the James Brady Press Briefing Room will take nine months. However, WMR's sources who cover the White House that the press corps will remain in the New Executive Office Building for the duration of the Bush administration. White House Press Secretary Tony Snow, a former talking head on Fox News, consistently arranges for his Fox friends to get exclusive stories ahead of their competitors. With the press corps now out of the White House, Fox has a tremendous advantage over other news networks.

The last time the press corps was temporarily moved out of the White House was 1902.

Aug. 16, 2006 -- According to WMR's Pentagon sources, there is absolutely no truth to the rumors circulating around Washington that Secretary of Defense Donald Rumsfeld wants to withdraw from Iraq. As one source who personally knows Rumsfeld put it, "Rumsfeld is totally committed to the Iraq military mission." The rumors are a ploy by the Republicans to try to convince voters that there is dissension within the ranks of the Bush administration over Iraq, thus providing cover for endangered Republicans running for re-election.



Rumors aside, Rumsfeld likes his war.

Aug. 16, 2006 -- Another Iran war sign. WMR's State Department sources report that the recent transfer of David Denehy from his job as Senior Adviser to the Assistant Secretary of State for Public Diplomacy Karen Hughes to the Office of the Vice President is another sign that the Bush administration is gearing up to attack Iran. Denehy also headed up the State Department's new Office of Iran Affairs, which was carved out of the Office of Arabian Peninsular Affairs for the sole purpose of creating the environment for a U.S. military attack on Iran. Denehy coordinated his activities with Farsi-speaking Iran Affairs Office personnel in Europe and Dubai, Iranian expatriates in Europe and Washington, DC, as well as with U.S. and Israeli intelligence officers.

Denehy, who once worked for the International Republican Institute (IRI) and is a committed neo-con, was closely associated with the Iraq invasion. Denehy's promotional climb at State was quick. He joined the department's Bureau of Intelligence and Research as an Iraq and Iran intern-analyst shortly after George W. Bush's inauguration in 2001. In 2003, Denehy was promoted to be Jerry Bremer's Deputy Director of Democracy and Governance in the Coalition Provisional Authority. In 2004, he became Acting Deputy Assistant Secretary for Democracy, Human Rights, and Labor and was again promoted to be Director of the Office of Strategic and External Affairs -- a State Department version of the Pentagon's Office of Special Plans. Denehy was a close associate of Assistant Secretary of State for Near Eastern Affairs Elizabeth Cheney, the daughter of Vice President Cheney.

In his role in the Vice President's office, Denehy's portfolio will include helping to cook the intelligence to justify a U.S. military strike on Iran and a push to overthrow Iranian President Mahmoud Ahmedinejad's government.

Dumb and Dumber

A Washington Post piece ran today called "No Evidence Iran Active in Iraq: US General." The general in question was identified as Major General William Caldwell, top U.S. military spokesman in Iraq.

Really General Caldwell? No Iranians active in Iraq?

That is certainly news to me as well as to:

- Moqtada al Sadr
- Ayatollah Sistani
- The Badr Organization (military wing of SCIRI)
- SCIRI (Supreme Council for the Islamic Revolution in Iraq with HQ in Iran)
- Hundreds of Revolutionary Guard personnel operating in Iraq
- Thousands of Iranian intelligence operatives working in Iraq
- Dozens of SCIRI members in the Iraqi parliament

- Hundreds of SCIRI members in local government posts

I could go on but I tire of stating the obvious – obvious that is, to everyone by our own military leaders in Iraq and the Pentagon. Since the earliest days of the war in 2003, Iranian agents of all stripes have been pouring over the virtually unguarded border between Iraq and Iran by the thousands, if not tens of thousands. That massive influx has not stopped, if anything, it has gotten worse.

While serving as a Counterintelligence Agent and Tactical HUMINT Team leader (THT) during Operation Iraqi Freedom in 2003, I personally apprehended Iranian agents as well as SCIRI and Badr Corps members during my tour there and they told me about many, many others, as well as some of the Iranian long term plans for Iraq. This was all reported up the chain of command at the time, but of course, no one listened. Why would the Army leadership want to listen to reports from its own intelligence operatives when they can make up their own Intelligence? Mind you, this was over three years ago.

It is particularly unnerving to have a senior military official after three years of war in Iraq put out such an asinine press release. That statement alone should make every American that cares anything about our presence in Iraq take notice. If a Major General, the senior U.S. military spokesman in Iraq can, with a straight face, put out an official statement claiming that there is no evidence of Iranian involvement in Iraq, then he should not only be removed from his post, but the entire senior military leadership in Iraq should be sacked as well. Through in the senior Pentagon leadership while we're at it since neither will happen.

Aug. 16, 2006 -- Another theft of personal data has been reported from the U.S. Department of Transportation Inspector General's office in Miami. A laptop computer containing several case files and sensitive personal information was stolen from a hotel room in Orlando. In April, an employee of the IG's office was attending a conference at the Wyndham Resort in Orlando and left her laptop in a locked conference room. When the employee returned, the computer was gone. As has been reported by WMR, most of these thefts are tied to a covert U.S. intelligence operation to populate Total Information Awareness surveillance databases. The theft was the second loss of personal data by the Transportation Department's Miami office. On July 27, another laptop was stolen from an employee's automobile. The computer contained personal information on 133,000 Floridians.

Aug. 15, 2006 -- There are reports of a number of stolen laptop computers on checked-in baggage on flights between the United Kingdom and other countries. The U.S. intelligence covert program to populate Total Information Awareness (TIA) surveillance databases have likely received fresh inputs of sensitive personal and financial data as a collateral benefit of the phony terrorist threat cooked up by Tony Blair's political allies along with the neo-cons in the Bush administration.

Aug. 15, 2006 -- More on NewsCorp/Fox News propagandizing. The Hatch Act prohibits federal employees covered by Civil Service regulations from engaging in political activity while performing their official duties or using their official titles while involved in purely political functions. Other laws prohibit federal employees from moonlighting for employers that could be

linked to their official duties. Not so for Labor Department Deputy Assistant Secretary for Intergovernmental Affairs Karen Czarnecki who regularly appears as a "Conservative Strategist" on Fox News and a "Conservative Analyst" on PBS's "To the Contrary" women's political talk show. According to Al Kamen's "In the Loop" column in the Washington Post, Czarnecki is paid for her appearances on PBS. There was no mention whether she is paid by Fox, but the way Fox handles guests is that "specialists" are not paid while "contributors" are compensated.

With Czarnecki's relationship with Fox, we have yet more proof of unethical behavior by Bush's senior appointees. Czarnecki, who has presided over the anti-labor Director of the Office of the 21st Century Workforce, is a senior adviser to Labor Secretary Elaine Chao, the wife of Kentucky Republican Senator Mitch McConnell.

In addition, Clive Goodman, Rupert Murdoch's royals editor for the *News of the World* (NOTW) who is under investigation for wiretapping the cell phones of the staff of Prince Charles and possibly Charles' own cell phone, wrote some blatant neo-con rhetoric about the future King in a February 9, 2003 article in NOTW. Goodman wrote, "despite being colonel-in-chief to 17 regiments, Charles has shown little public support for the soldiers, airmen and sailors who are about to risk their lives in a Gulf conflict. There are also worries that he makes no secret of his anti-American views in conversations with members of Arab royal families and their leading officials. A Whitehall source said: 'Downing Street tries not to involve the prince in anything—because they have concerns over how he will react. He has this lunatic view he is the voice of the people.'"

Continuing with his anti-Charles tirade, Goodman wrote, "The prince's views have led to a worrying split with the American leadership. Two months ago, Charles had to abandon an official visit to the US because the White House made it clear he wasn't wanted. The snub—directly from President Bush—came after security sources advised that Charles's presence in America would be 'very unhelpful.' Washington diplomats were concerned the prince would show his disapproval during meetings with President Bush. Charles—who reads the Koran every day and often adopts Islamic dress at home—spends long hours discussing the Middle East's problems with Saudi royal family members. One of his closest friends is the former Saudi ambassador Ghazi Algosaibi who wrote a poem in praise of the first woman suicide bomber. Algosaibi said that the 'doors of heaven are opened for her.' He once described the Israelis as worse than Nazis and he was a regular guest at Highgrove—Prince Charles's country home—before he was recalled by his government last year. Charles is also close to King Abdullah of Jordan. His glamorous wife Queen Rania is a close friend of the prince's partner, Camilla Parker Bowles and is a regular guest at St James's Palace. In private the prince talks about 'American imperialism' collapsing the whole of the Middle East. 'Of course Saddam is an evil man, but American imperialism will not solve the problem,' he said in one discussion. He sympathizes with his Saudi royal friends when they talk about their fears of America's true intentions in Iraq. One close friend said: 'They believe the US intends to collapse the whole Gulf economy and take control of oil. Once that happens the tensions in Israel and Palestine will explode.' Charles's meeting three days ago with French President Jacques Chirac was fraught with diplomatic concerns. Before the meeting the Foreign Office asked the Prince of Wales's staff if he would promise not to discuss Iraq. They said yes, but Charles would feel free to give an opinion if Chirac raised Iraq first. Downing Street is understood to have washed its hands of winning Charles's support. 'At such a sensitive time his views are wrong, wrong, wrong,' said a Whitehall source. Unfortunately he is making them a little too widely known."

This is the background of Charles' covert support for the political coup against Tony Blair by Labor Party rebels. According to London-based political observers, Charles connects himself with the left-wing of the Labor Party, particularly that which is based in Scotland. It was because of royal support that Blair and his allies, notably Home Secretary John Reid, Attorney General Lord Goldsmith, and Lord Falconer, decided to launch the phony liquid bomber terror threat and put down the imminent Labor revolt against Blair and his neo-con allies.

about than his blatant racism. Last week, Allen referred to a Jim Webb worker who is videotaping Allen's campaign appearances, as a "macaca," an Asian monkey. The campaign worker, S. R. Sidarth, a native Virginian (unlike Allen) who is of Asian Indian heritage, was then welcomed to America by Allen. Sidarth was the only non-white face in the crowd at the Allen rally.

"Macaca" is also the name of a South African town and the term was used by racist South Africans in the same way racists in the United States use the "N" word to describe blacks. Allen, who was a supporter of South Africa's apartheid regime, is well aware of the racial nature of the term. Before he was governor of Virginia, Allen had draped on his wall at his second cabin home the South African "Bantustan" flag of Zululand along with the Confederate flag. Allen's office once featured a noose hanging from a tree.

Playing up to the Republican religious base in southern Virginia, Allen's spokesman and Karl Rove clone, Dick Wadhams (his name is more illustrative if one omits "hams"), dismissed the charges that Allen used a racial epithet. The Allen campaign said that Allen was referring to Sidarth's haircut and that Allen actually meant to say "Mohawk." Sidarth does not have a Mohawk-style haircut and the double entendre "Indian" explanation was clearly digging Allen's hole deeper. Yesterday, Allen was forced to apologize for his comment.

However, the rumors about Allen's sexual orientation are beginning to re-emerge as the November election draws closer. Attention is being focused on a number of gays on Allen's Senate staff. In addition, Allen began running TV ads very early in the campaign featuring his with his family. Allen's reported frequenting of Richmond bars, known for their gay clientele, while he was governor of Virginia, is a focus of WMR's investigation. The gay rumors, at the very least, will discourage some of Allen's religious base in southern Virginia from turning out to vote for him in November.

[Democratic candidate Jim Webb](#), Ronald Reagan's Navy Secretary and a wounded Marine Corps Vietnam vet, is eating into Allen's traditional support base in the heavily military Tidewater region of Virginia. Allen, born in Nixon territory, Whittier, California, in 1952, never served in the military (in fact, Allen's father, Washington Redskins coach George Allen, was a Nixon favorite). While Webb was fighting in Vietnam, Allen was driving around Los Angeles in a pickup truck that sported a Confederate flag. Senator Allen, whose physical fitness as the teenage son of football coach Allen was never in doubt may have had other "issues" that kept him out of the draft and the military.

Aug. 15, 2004 -- Naval Security Document Lumps Journalists With Foreign Spies

A recently obtained Naval Operations Security Plan (OPSEC) expressly reveals the U.S. Navy's contempt for journalists, whom it views in the same light as – and arguably a less favorable light than – foreign spies. The document was discovered while researching a federal contract to support psychological operations (PSYOPS) that the U.S. military conducts worldwide, a \$100 million award secured by Virginia-based CACI International.

While the document – which was labeled FOR OFFICIAL USE ONLY – had been available for public viewing, the Navy has since removed all links related to the contract, replacing those links with the phone number of a Naval procurement specialist handling the account.

CACI will carry out much of its PSYOPS and electronic-communications support role at the Naval Air Warfare Center facilities in Patuxent River, Maryland, where the Navy's Special Communications Requirements (SCR) Division is located. The SCR Division designs and maintains federal systems for C4ISR – command, control, computers, communications, intelligence, surveillance and reconnaissance. Consequently, the OPSEC plan serves as a precautionary guide for contractors visiting the Patuxent River Complex and Naval Air Station, advising visitors to be mindful of potential "human intelligence" (HUMINT) threats that foreign collection services pose to national security . . .

. . . Wayne Madsen, a former Naval officer and Naval Intelligence staffer, said that while this view of the media is troubling, he is not shocked that the Navy has incorporated its negative perspective into policy.

"The U.S. Navy hierarchy, by far, is more conservative than its counterparts in DoD, including the Marine Corps," Madsen said in an interview. "That is why they entertain these dangerous notions of controlling the media. The Navy's track record on cover-ups – USS Iowa turret blast, Tailhook scandal, USS Vincennes downing of IranAir flight, and other outrageous censorship and disinformation – has made it and the open media enemies for a number of years. It's not surprising the Navy would suggest a plan to control the media and liken them to foreign intelligence agents."

Aug. 14, 2006 -- There is an increasing body of evidence on both sides of the Atlantic that Rupert Murdoch's News Corporation has engaged in a pattern of news manufacturing and illegal activities to hype the "liquid bomb" aviation threat and influence political developments. As WMR reported on Aug. 11, the move that prompted Murdoch, British Prime Minister Tony Blair, and George W. Bush to stage a phony terror threat -- namely, the attempted political coup against Blair by members of his own Cabinet and Labor Party -- was based on a Murdoch-approved illegal wiretap by his London-based *News of the World* royals editor that hacked into the voice and text cell phone messages of three members of Prince Charles' staff. Murdoch learned of a Labor Party move, supported by Prince Charles, to dump Blair as Prime Minister. The police investigation of that incident has now, according to *Time Europe*, has now graduated from the London Metropolitan Police to the department's anti-terrorism unit, the same unit that is investigating the liquid bomb hoax perpetrated on global air travelers by Murdoch and a vacationing Blair and Bush. The anti-terrorism probe is now focused on British cell phone companies Vodafone and O2 and is expanding to investigate whether the News

Corporation eavesdropping project was also directed against the reported major plotters against Blair: Chancellor of the Exchequer Gordon Brown, Deputy Prime Minister John Prescott, Leader of the House of Commons Jack Straw, Northern Ireland Secretary Peter Hain, Foreign Secretary Margaret Beckett, Environment Secretary David Miliband, and Home Affairs Committee Chairman John Denham, all to the left of Blair and all critical of Blair's close relationship with Bush and Blair's acquiescence to Israel's invasion of Lebanon.

In reaction to the plot against Blair, Home Secretary John Reid, who has now supplanted Brown as the neo-con's heir apparent to Blair and who is a firm supporter of the Bush administration, and members of the British security services took over the "investigation" of the liquid bombing "plot," working closely with their counterparts in the Bush administration. Reid, not Deputy Prime Minister Prescott, took over as chair of the Cabinet Office Briefing Room-A (Cobra) meetings during Blair's absence in Barbados.

WMR has also learned of other NewsCorp/Fox News political chicanery. During Rep. Cynthia McKinney's August 8 election night rally at the Omega Center in the DeKalb County, outside of Atlanta, witnesses saw several off-duty Atlanta policemen leave a Fox 5 News truck and engage in name calling, uttering racial and religious epithets, and engaging in other political chicanery such as attempting to start fights with McKinney supporters. Fox and other networks

later reported that the offensive comments were made by McKinney supporters. The president of Fox News is Roger Ailes, a former Republican political operative and propagandist. WMR is pursuing this story.

AFFIDAVIT OF FAYE COFFIELD

State of Georgia
County of DeKalb

1. My name is Faye Coffield and I am a resident of DeKalb County, Georgia. I have been a resident of DeKalb County continuously since 1979. I am of sound mind and make this Affidavit based upon facts and circumstances of which I have personal knowledge.
2. From December 1981 until December 2002, I was employed as a Police Officer by the Atlanta Police Department. My highest rank was Sergeant. During the course of my work, I was employed worked various assignments including the Atlanta Housing Authority Precinct from approximately 1997 to 2000. During that period I worked with Sgt. Walter (?) A. Bishop.
3. Sgt. Bishop I never liked one another for specific reasons. I also assisted an officer in filing an Internal Affairs Complaint and a Departmental Complaint against Sgt. Bishop for allowing Officers to report for duty on a holiday, fill out a time sheet stating they had worked, when in fact they had actually almost immediately upon arriving at work gone home. There was however, one officer, I believe a female, who arrived late and was told she would have to use her compensation or vacation time. This was done, the officer later learned the other officers had lied about working and she thus filed a complaint. To the best of my know the complaint was sustained and several officers and Sgt. Bishop received discipline because of it. This incident happened on a day when I was scheduled off and thus I was not included in it.
4. I worked as a volunteer in Campaign to Re-Elect Congresswoman McKinney beginning in approximately mid-June. I received no monetary compensation or promises of employment.
5. On the night of August 8, 2006 at approximately 2345 hours myself and at least two other people were standing outside at the Omega Center.
6. Walter Bishop, who I had not seen since leaving the police department walked over spoke, shook my hand and asked me if I remembered him. I stated I did and that was the extent of my dealing and/or conversation with him at that time.
7. I observed Walter Bishop and several white males standing with members of a television crew, entering the Fox news truck and another large dark colored news truck which had the license plate number 3411 AEP, Georgia or 3911 AEP Georgia.
8. I was later advised by persons at the location they had seen several white men "...with guns..." near these TV trucks and wandering through the crowd. One of the white males was

pointed out to me and it was Walter Bishop. I dismissed the matter at that time because I knew Bishop had previously been a police officer. I was also informed one of the news crews had "brought their own security."

9. After Congresswoman McKinney made her speech, we were all walking down the westbound walk way towards her vehicle. I was on the extreme outer edges on the North side of her. I observed a white male who had been with Bishop running towards us. I was not initially concerned because I believed this man was in fact a law enforcement official.

10. As we began to reach the news truck this man shouted "...Go build your ...Mosque..." He continued to shout racial slurs. Others with me heard this.

11. This man and a man who was not a part of the security team began to argue. I told the man to leave.

12. The white man then asked me "where are you licensed". He then stated he had ran me and I did not have a Georgia license. I informed him that I owned a Private investigation Agency and a Security Agency both of which were licensed by the state.

13. He then made additional statements to me upon which I told him he could do as he pleased but I would sue him and the station.

14. I have now been informed by a person who was nearby that after I left she heard comments made by Walter Bishop.

15. I also believe Walter Bishop was a member of the Atlanta Branch of the Fraternal Order of Police while we were employed there. I was never a member.

16. It is ironic of all the police officers in this State, the only one this news outlet could find is one with whom I had an extreme dislike and one who I filed charges on. I also find it ironic Walter Bishop walked over and shook my hand and stood near me until I moved considering he did not shake my hand and barely spoke to me when we worked together.

After they blindfolded and handcuffed Dr. Sarki they started beating him causing him to bleed profusely. They confiscated Dr. Sarki's laptop and U.S. passport. Dr. Sarki's neighbors witnessed the beating and the cruel treatment the doctor received as he was being showed into a police van. Since then his whereabouts have not been disclosed to anyone. His family and friends fear for his life. Thanks to his attorney's investigations, he concluded that Dr. Sarki was or is being kept in military barracks under ISI at Karachi. However, Pakistani military and civilian authorities have been denying Dr. Sarki's arrest or involuntary disappearance at their hands."





Who are the real sponsors of terror? Bush and his "General General," Pervez Musharraf, benefactor of terrorist groups throughout Pakistan, Kashmir, and Afghanistan.

"Munir Mengal is a TV journalist who applied for launching a Baluchi language private satellite TV channel. On April 4, 2006 he was whisked away by intelligence agents as soon as he landed at Karachi International Airport on a flight from UAE. "Chetan Bajir is a member of Sindhi Hindu communities in Sindh. "A female physician [Dr. Shazia Khalid] who was raped in high security Pakistan Petroleum Limited (PPL) guarded by a special services group of Pakistan's army is still looking for justice. It is alleged that Captain Hamad, an army official, was one of the perpetrators. Pakistan's President Musharraf ([Bush's and Blair's 'war on terror' partner], himself, before the conclusion of the official judicial probe, exonerated Captain Hamad of the accusations. Restoration of the FCC's Fairness Doctrine for radio and TV. Federal regulations requiring corporations that own news organizations to spin them off to private journalistic cooperatives. No corporate or government control of the Internet. A total ban on dual nationality for U.S. citizens.
8. Federal taxation of all religious-connected businesses and mega-properties. Retroactive repeal of tax exempt status for all foundations and institutes connected with the Bush administration's war policies. Requirement that all organizations that represent foreign countries and interests register as foreign agents with the Department of Justice.
9. Repeal of all Bush administration anti-constitutional laws and administrative orders.
10. Aug. 12/13, 2006 -- New false flag terrorist link involving diamond trade discovered in New York. A Syrian Jew named Rimon Alkatri was indicted by a New York City grand jury for phoning a false terrorist threat to the New York City police in May. The indictment charged Alkatri with making a false terrorist threat in the first degree. Alkatri was arrested on July 31, a little over a week from the hype generated by the "great airplane liquid bombing hoax" reported by WMR (see below).

Alkatri, who owns the El Castillo de Oro jewelry store on Knickerbocker Avenue in Brooklyn and who arrived in the United States in 1996, was arrested by police while he was leaving his apartment in a Syrian Jewish neighborhood on East 9th Street. In May, Alkatri, using the alias Jose Rodriguez, and claiming to be from Israel, said he overheard five Syrian employees of his store use the phrase "Allahu Akbar" (God is great) and that they were plotting to hide explosives in hollowed-out jewelry and perpetrate a suicide bombing in the New York subway system on the Fourth of July. In the ten or so days before police became suspicious of Alkatri, there were no moves by the Transportation Security Administration to ban the wearing of jewelry by passengers on aircraft.



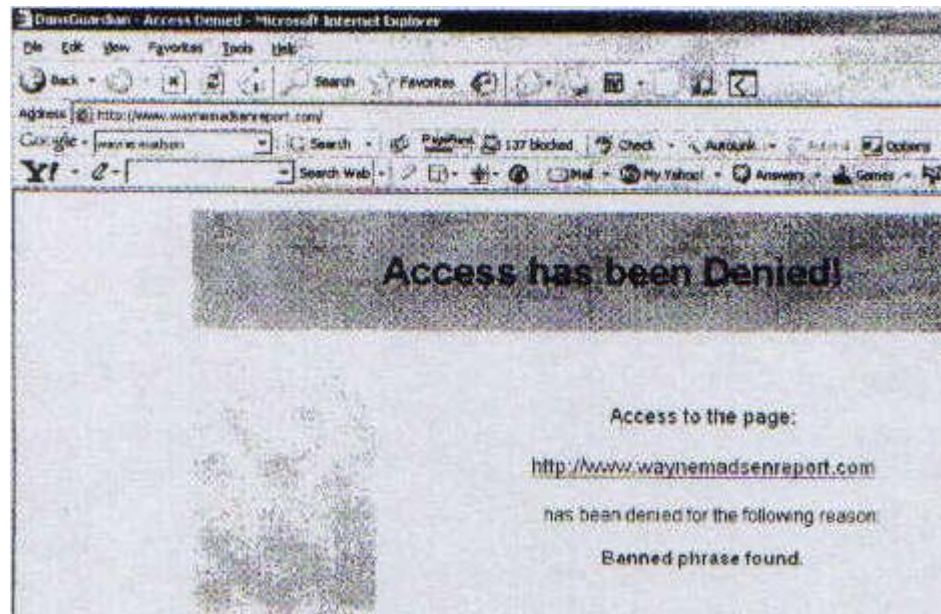
Israeli connection to New York City subway Fourth of July terrorist hoax.

Police soon became suspicious of "Jose Rodriguez's" account. The Israeli connection promoted police to alert Israeli authorities and a New York City detective stationed in Jerusalem to pursue the case. Police later discovered that the five Syrian "conspirators" identified by Alkatri were not even Muslims, but Christians and Jews.

Alkatri was not the first person associated with the international diamond business to have been involved in a terrorist threat. In 2003, Yehuda Abraham, a dual U.S.-Israeli citizen, global diamond dealer, and native of Afghanistan, was charged with money laundering for an Indian weapons smuggler named Hemant Lakhani who was attempting to purchase Russian portable missile launchers to bring down American passenger planes in the United States. Abraham was later convicted in the scheme that also involved a Malaysian bag man associated with the Southeast Asian Al Qaeda off-shoot Jemaah Islamiya. One of Abraham's chief diamond businesses was in Bangkok. Osama Bin Laden used an Algerian, who dressed as a Hasidic and used the name "Cyril Jacob," to sell West African blood diamonds in Hatton Garden, the Jewish diamond district of London. The editor's book, ["Jaded Tasks,"](#) has a chapter on the connections between the diamond trade and terrorist financing.

Aug. 12/13, 2006 -- Another day and another personal data theft report. Some 6,000 patients of the Madrona Medical Group in Bellingham, Washington, are the latest victims of data theft, a pandemic across the United States. A former employee of the medical group was arrested for illegally downloading patient names, Social Security Numbers, dates of birth, and other sensitive information to his lap top computer. The perpetrator was arrested on June 8. [WMR's data theft chart](#) has been updated.

Aug. 12/13, 2006 -- WMR received this screen shot from a reader who reports that we are banned by the web content filtering program DansGuardian. The web site for DansGuardian uses phrases like "blacklists" and "bad sites" to describe web sites that are on their banned list.

Aug. 11, 2006 -- UPDATED. According to knowledgeable sources in the UK and other countries, the Tony Blair government, under siege by a Labor Party revolt, cleverly cooked up a new "terror" scare to avert the public's eyes away from Blair's increasing political woes. British law enforcement; neo-con and intelligence operatives in the United States, Israel, and Britain; and Rupert Murdoch's global media empire cooked up the terrorist plot, liberally borrowing from the failed 1995 "Oplan Bojinka" plot by Pakistan- and Philippines-based terrorist Ramzi Ahmad Yousef to crash 11 trans-Pacific airliners bound from Asia to the United States. In the latest plot, it is reported that liquid bombs were to be detonated on 10 trans-Atlantic planes outbound from Britain to the United States.



British and American authorities permitted a man with a liquid bomb to board a U.S.-bound flight in Heathrow on Aug. 6 -- the pilot foiled secret UK-US attempt to hype an incident en route to or at Boston Logan.

The London terror plan was "known" last Sunday by British and American authorities,

according to the [Indian press](#). American Airlines flight 109 from London Heathrow to Boston boarded a family of five, however, after the plane left Heathrow authorities determined that the father appeared on a British suspect list drawn up after the 7/7 London transit attacks. At first, the pilot was instructed to fly all the way to Boston where U.S. authorities could claim credit for apprehending the suspect. However, the pilot, fearing for the safety of his passengers and crew, refused and quickly returned to Heathrow without informing the passengers. Once on the ground, it was discovered that the male had in his carry-on baggage the type of combination liquid explosive and electronic device now being hyped by the British and American media.

British sources report that the reason for the delay in informing the airlines and traveling public about the liquid bomb on the American flight was to maximize the beneficial political impact for Blair and George W. Bush, both plummeting in the polls from the situations in Iraq and Lebanon.

Earlier this week, two employees of Murdoch's London tabloid, *News of the World*, were charged with hacking into the voice and text cell phone messages of three members of the staff of Clarence House, the residence of Princes Charles, William, and Harry. One of those charged with the wiretapping was Clive Goodman, the Royals editor of the *News of the World*. The same paper earlier tried to politically damage two anti-Iraq war British politicians -- Scottish Socialist Tommy Sheridan and Respect Party MP George Galloway. The paper charges that Sheridan was unfaithful to his wife by going to swinger's clubs. He won a quarter million dollar lawsuit against the paper. Galloway was confronted by Mazher Mahmood, an individual who uses the moniker "Fake Sheik," who posed as a wealthy Arab businessman and tried unsuccessfully to get Galloway to accept cash and make anti-Semitic remarks. In fact, Mahmood was and continues to be a reporter for *News of the World*, his continued employment approved by Murdoch. Goodman has merely been suspended by Murdoch but he has not been fired.

However, what prompted Murdoch and Blair to hype a new global "terror" threat was what Murdoch learned from eavesdropping on the phone calls of Prince Charles' staff at the future king's office, home, and limousine. The eavesdropping revealed that Charles was working with Chancellor of the Exchequer Gordon Brown, who is to the left of Blair, to conduct the same type of political maneuver that John Major used to oust Margaret Thatcher from office. London's left-wing Mayor, Ken Livingston, was also in on the Charles-Brown plan and it was expected that in return for his support, Livingston would get a senior position in a Brown cabinet -- a development that sent shock waves through the neo-con circles in London, Washington, and Jerusalem, including British Home Secretary John Reid and Homeland Security Secretary Michael Chertoff. The Charles-Brown plan was briefed by Blair to Bush

during the former's recent visit to Washington. However, because the phony terror plot was known to both leaders -- they decided to be away on vacation when the terror plot was "uncovered." Bush is vacationing at his Crawford, Texas "ranch," while Blair is on vacation in Barbados, staying at Sir Cliff Richard's luxurious villa.

After Blair met with Bush in Washington, he flew to California where on July 30 he attended Murdoch's News Corporation private corporate executive conference at the posh Inn at Spanish Bay golf resort in Pebble Beach. Blair met with Murdoch, Israeli former Prime Minister Shimon Peres, Arnold Schwarzenegger, Newt Gingrich, and various Fox, Star, and Sky News executives. The final touches were agreed to by Blair and Murdoch on how the fake terror plot would play out in Murdoch's media empire.

Blair told Bush that a Brown government would move to withdraw British troops from Iraq, break the "special relationship" with the Bush White House, and move closer to the European Union and the United Nations.

The Israeli attack on Lebanon created a rift within Blair's Cabinet with some former Blair loyalists signaling their support for the political coup against Blair. As a result, a suspect passenger was permitted to board an American aircraft at Heathrow with a liquid bomb to lay the groundwork for the media and travel hysteria five days later.

The wiretapping of Charles' messages also indicated that he has weighed in with various European royal families to discourage them from inviting Bush on state visits to their nations. This, reportedly upset the Bush and Blair regimes, who were working together to improve Bush's image in Europe. The White House's displeasure with the monarchies in Spain, Belgium, Sweden, Luxembourg, and Norway are a direct result of the Murdoch eavesdropping on Charles' staff.

Not surprisingly, after Galloway tore into a Sky News reporter on a recent televised interview, *The Sun*, a Murdoch paper, is now reporting that one of the 24 British aircraft liquid bomber suspects now under arrest, Waheed Zaman, met with Galloway "many times." The paper quotes the sister of the suspect. A Galloway spokesman denies that Galloway knows the suspect. What is suspect is the Murdoch media empire that makes up news and commits illegal acts to provide cover for the false flag operations being conducted by Britain, the U.S., and Israel.

Pakistan's Inter Services Intelligence (ISI) agency has helped provide the cover story for the alleged liquid bombers. Working with British and U.S. intelligence, the ISI says it broke up the plot after arresting terrorist suspects in Lahore and Karachi. However, the ISI claims that the men were affiliated with the Kashmiri terrorist group Lashkar-e-Toiba, a group that is run and funded by the ISI itself.

The disclosure of the Charles-Brown plot has already created a backlash from the neo-cons.

The Murdoch media is already floating the rumor that Home Secretary Reid is now Blair's chosen successor, while there will be an effort to scandalize Charles in an effort to convince the British public that it would be best to skip over him and have Prince William assume the throne upon Queen Elizabeth's death or abdication.

British commentators are noting that it is Reid, a noted neo-con, who is chairing national security "Cobra" meetings in Blair's absence. Blair bypassed Deputy Prime Minister John Prescott and many political observers believe that Prescott was passed over because of evidence that he was involved in supporting the Charles-Brown coup. Prescott chaired Cobra meetings in the wake of the July 7, 2005 (7/7) London transit bombings.

Meanwhile, Republican governors Arnold Schwarzenegger and Mitt Romney used the occasion to boost their sagging popularity by placing their states' National Guardsmen at major airports in their states.

Aug. 10, 2006 -- Rumsfeld and Israeli spy Larry Franklin reported to have been very close.

Larry Franklin, the Pentagon Office of Special Plans Iran and Defense Intelligence Agency (DIA) analyst and reserve Air Force Lieutenant Colonel who was temporarily posted at the U.S. embassy in Tel Aviv, served as a virtual personal liaison for Defense Secretary Donald Rumsfeld, according to U.S. intelligence sources who have spoken to WMR. Franklin, who pleaded guilty to passing classified information, including CIA Sensitive Compartmented Information (SCI), to two America Israel Public Affairs Committee (AIPAC) officials who passed the information to an Israeli embassy Mossad agent, was sentenced to twelve years and seven months in prison and a \$10,000 fine in January. The two AIPAC employees, Steven Rosen and Keith Weisman, were indicted for illegally receiving classified information. Franklin and other neo-con cell members -- Harold Rhode and Michael Ledeen -- conducted secret negotiations with the knowledge of Rumsfeld and Pentagon policy chief Douglas Feith -- with the Iranian government through the offices of Iran-Contra co-conspirator Manucher Ghorbanifar. According to U.S. State Department sources, Rhode is also very close to Iranian neo-con ally and Iraqi oil industry majordomo Ahmad Chalabi and that the relationship is said to be more than merely professional.

Although the Pentagon quickly distanced itself from Franklin after his arrest and revelations of the AIPAC-Mossad espionage program, U.S. intelligence sources report that Franklin accompanied Rumsfeld on his May 1, 2003 and February 26, 2004 trips to Kabul, Afghanistan and acted as his personal Pushto and Dari interpreter with Afghan officials. The sources claim that Franklin had a collegial photograph taken of himself with Rumsfeld and Afghan President

Hamid Karzai during the Afghan visit. Franklin also speaks Farsi, Urdu, Arabic, and Hebrew. Franklin boasted to his colleagues that he learned the languages from his Pakistani, Afghan, and Iranian colleagues and bosses while working as a tax cab driver in New York City.

U.S. intelligence officials also revealed that Franklin repeatedly attempted to recruit other U.S. intelligence personnel to work in a "NOC" or "non official cover program." Later, it was discovered the "NOC" program was not American but Israeli.

The fact that Franklin was so close to Rumsfeld, whose coterie of advisers has been very small and largely non-inclusive of uniformed military personnel, makes Rumsfeld a prime suspect in the AIPAC espionage case and a possible severe national security risk.

Aug. 10, 2006 -- Another sensitive laptop computer stolen amid hype over missing Egyptian students and alleged threat to bomb 10 Britain to U.S. flights with liquid bombs. Within the last 24 hours, the American public has been subject to government and media hype concerning 11 "missing" Egyptian students who arrived in the United States last month but failed to report for their classes at Montana State University and Britain's arrest of 21 Britons of "south Asian" descent who were arrested for plotting to blow up U.S. bound airplanes from Britain with liquid bombs disguised as toiletries. Later, one Egyptian was arrested in Minneapolis and another two were picked up in New Jersey.



Massive theft of transportation workers' personal data now reported from Florida.

Lost in the hype over the American and British arrests was the theft of yet another laptop computer containing extremely sensitive information on those who work in the air and ground transportation industry in the United States. The Miami, Florida Department of Transportation Inspector General's office reported that on July 27 a laptop containing personal and sensitive information on 133,000 Florida pilots and commercial drivers was stolen from a government computer in Doral, Florida. The names, Social Security Numbers, dates of birth, and addresses of Florida pilots and commercial and regular driver's licenses in the Miami-Dade and Tampa Bay regions were stolen. The theft of the computer was not reported to Department of Transportation officials in Washington until July 31.

WMR has been repeatedly reporting that, according to U.S. intelligence sources, the pandemic

of personal data thefts are part of a covert Bush administration-sanctioned program to populate the databases of Total Information Awareness system databases.
