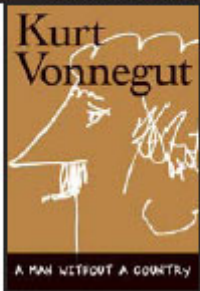

In case you don't know, the ballots from the 2004 Presidential Election in Ohio have never actually been counted. Or even recounted.

The "official" recount, called for by the Green and Libertarian Parties in the state, was gamed and carried out completely against state law by Ohio's Sec. of State (and Bush/Cheney's Re-Election Committee Co-Chair) J. Kenneth Blackwell.

The Green and Libertarian Parties are **still challenging** that recount in Federal Court. As well, two Cuyahoga County Election Officials were **indicted last August** for gaming that (non)recount.

And today, **AP informs us**, a third one has just been nabbed as well...

CLEVELAND (AP) — The third highest ranking employee at the Cuyahoga County Board of Elections has been indicted on charges of mishandling ballots during the 2004 presidential election recount.

Jacqueline Maiden is the third board worker charged with six counts alleging that Ohio laws were not followed in the selection and review of ballots for the recount.

... Maiden, now the board's elections coordinator, was the director of the elections division during the recount in December 2004.

Two other board workers, Rosie Grier and Kathleen Dreamer, were indicted in August and scheduled for trial May 8. Dreamer was the manager of the board's ballot department and Grier was an assistant manager.

Amazingly enough -- or perhaps not, since this *is* Ohio, after all, where the rule of law no longer actually applies -- the story also reports that "All three [indicted] employees continue to work at the board."

"We're in the process of converting to the electronic voting, and we need our best people," board chairman Bob Bennett said. "We've moved them from any responsibility of recount or responsibility of ballots."

Sure you have, Bob. We all feel much better. We guess by "best people" he means the ones who are most indicted.

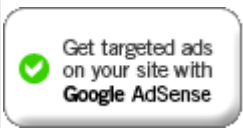

questioning. And it's been alluded to that there are more facts that have not been made known yet. The possibility of this leaves it questionable whether all the facts have been brought forth in this investigation or not. Without question, this is tantamount to a fair and honest outcome in making certain all responsible are held accountable.

While attending the Certification of the Recount meeting of the Cuyahoga Board of Elections, I witnessed both the Director, Michael Vu, as well as Ms. Maiden, after being asked if the votes had been counted in private prior to the recount that it was both Mr. Vu and Ms. Maiden who admitted that they had. However, interestingly enough, it was Mr. Vu who added, "they did it to facilitate it for the observers"...such a statement, in my mind, calls into question how Mr. Vu can continue to claim ignorance of his subordinates' actions if he could say such a thing in the first place. Shouldn't he have expressed shock instead?

I lived in Cleveland during this time and I dealt primarily with Ms. Maiden when dealing with the Cuyahoga BOE. She, in fact, in an interview I participated in, with both her and Ms. Dreamer present, they said they would be following recount procedures that had been followed for years prior to their employment in their respective positions.

To my knowledge, Cuyahoga county had conducted recounts prior to the 2004 General Election and had used these same procedures for those recounts. I find it highly unlikely that no one at the Board of Elections, other than Ms. Maiden, Grier and Dreamer, were aware of what those procedures were. Again, I think this needs to be investigated further to make certain who knew what and when, before condemning these 3 women.

By that I mean, it should be ascertained to what extent both the Director, Michael Vu and Deputy Director, Gwen Dillingham, have a "legal" responsibility to not only know what those procedures are but to oversee strict adherence to those procedures by their subordinates. That's why every board of elections has a Director and Deputy Director. The buck should stop with them ultimately.

More attention should be made to how Mr. Baxter is handling this investigation and the steps he has taken to ensure that no stone is left unturned, even if it leads to the higher ups, Mr. Vu and Ms. Dillingham. We certainly don't need another "dog and pony show" in something of this importance, not to mention, the message it would send to the rest of the country were those truly responsible were to be given a free pass because of an ineffective or possibly biased investigation.

That is his duty as the prosecuting attorney in this case and he should be held to the highest standards possible. These women and the citizens of Cuyahoga County deserve no less, if justice is to be served.

Regarding the viral email claiming to be from Bradblog - I have been receiving it for some time now. Several different viruses have been used. While this can happen from anyone getting a virus and then having it send itself out to their address book entries, what I find interesting is that while I have mailed to and received legit mail from Brad at both my home and work addresses, only my home address has been targeted. That is the address linked

to my name here. This would seem to preclude it being Brads computer. Therefore it seems that it may be intentionally directed at me. The "From" address in these types of mail are almost always spoofed and not the real source, so again I doubt it is from Brad's computer.

As always - run an antivirus and don't open any attachments you are not expecting from someone you know. Even then you can get tricked - I caught the nimda virus years ago from a source I knew and the subject line was about a job we were working on together. That's how smart some of them are.

If you don't have an anti virus get **AVG Antivirus Free Version**. I run it on all my machines and it works great. It updates daily not weekly like Norton etc. and it's free!
