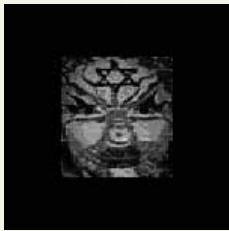

How Mossad got America to bomb Libya and fight Iraq by, Victor Ostrovsky and Claire Hoy

Revealing the facts as I know them from my vantage point of four years spent inside the Mossad was by no means an easy task.

Coming from an ardent Zionist background, I had been taught that the state of Israel was incapable of misconduct. That we were the David in the unending struggle against the ever-growing Goliath. That there was no one out there to protect us but ourselves - a feeling reinforced by the Holocaust survivors who lived among us.

We, the new generation of Israelites, the resurrected nation on its own land after more than two thousand years of exile, were entrusted with the fate of the nation as a whole.

The commanders of our army were called champions, not generals. Our leaders were captains at the helm of a great ship. I was elated when I was chosen and granted the privilege to join what I considered to be the elite team of the Mossad.

But it was the twisted ideals and self-centered pragmatism that I encountered inside the Mossad, coupled with this so-called team's greed, lust, and total lack of respect for human life, that motivated me to tell this story.

It is out of love for Israel as a free and just country that I am laying my life on the line by so doing, facing up to those who took it upon themselves to turn the Zionist dream into the present-day nightmare.

The Mossad, being the intelligence body entrusted with the responsibility of plotting the course for the leaders at the helm of the nation, has betrayed that trust. Plotting on its own behalf, and for petty, self-serving reasons, it has set the nation on a collision course with all-out war.

One of the main themes of this book is Victor's belief that Mossad is out of control, that even the prime minister, although ostensibly in charge, has no real authority over its actions ...

The Mossad - believe it or not - has just 30 to 35 case officers, or katsas, operating in the world at any one time. The main reason for this extraordinary low total, as you will read in this book, is that unlike other countries, Israel can tap the significant and loyal cadre of the worldwide Jewish community outside Israel. This is done through a unique system of sayanim, volunteer Jewish helpers.

My first six weeks were uneventful. I worked at the downtown office, essentially as a gofer and filing clerk. But one chilly day in February 1984, I found myself joining 14 others on a small bus. ... This course was to be known as Cadet 16, as it was the sixteenth course of Mossad cadets.

He walked briskly to the head of the table while the other two sat at the back of the room. "My name is Aharon Sherf," he said. "I am the head of the Academy. Welcome to the Mossad. Its full name is Ha Mossad, le Modiyn ve le Tafdikim Mayuhadim [the Institute for Intelligence and Special Operations]. Our motto is: 'By way of deception, thou shalt do war.'

"It's the old Trojan dick trick." He lit a cigarette.

"What's that?" I couldn't help smiling; I'd never heard it called that before.

"I knew that would get your attention," he said, grinning. "Shimon activated Operation Trojan in February of this year."

I nodded. I'd still been in the Mossad when that order was given, and because of my naval background and acquaintance with most of the commanders in the navy, I participated in the planning for the operation as liaison with the navy.

A Trojan was a special communication device that could be planted by naval commandos deep inside enemy territory. The device would act as a relay station for misleading transmissions made by the disinformation unit in the Mossad, called LAP, and intended to be received by American and British listening stations. Originating from an IDF navy ship out at sea, the prerecorded digital transmissions could be picked up only by the Trojan. The device would then rebroadcast the transmission on another frequency, one used for official business in the enemy country, at which point the transmission would finally be picked up by American ears in Britain.

The listeners would have no doubt they had intercepted a genuine communication, hence the name Trojan, reminiscent of the mythical Trojan horse. Further, the content of the messages, once deciphered, would confirm information from other intelligence sources, namely the Mossad. The only catch was that the Trojan itself would have to be located as close as possible to the normal origin of such transmissions, because of the sophisticated methods of triangulation the Americans and others would use to verify the source.

In the particular operation Ephraim was referring to, two elite units in the military had been made responsible for the delivery of the Trojan device to the proper location. One was the Matkal reconnaissance unit and the other was Flotilla 13, the naval commandos. The commandos were charged with the task of planting the Trojan device in Tripoli, Libya.

On the night of February 17-18, two Israeli missile boats, the SAAR 4-class Moledet, armed with Harpoon and Gabriel surface-tosurface missiles, among other weaponry, and the Geula, a Hohit-class missile boat with a helicopter pad and regular SAAR 4-class armament, conducted what seemed like a routine patrol of the Mediterranean, heading for the Sicilian channel and passing just outside the territorial waters of Libya. Just north of Tripoli, the warships, which were visible to radar both in Tripoli and on the Italian island of Lampedusa, slowed down to about four knots - just long enough to allow a team of twelve naval commandos in four wet submarines nicknamed "pigs" and two low-profiled speedboats called "birds" to disembark. The pigs could carry two commandos

each and all their fighting gear.

The birds, equipped with an MG 7.62-caliber machine gun mounted over the bow and an array of antitank shoulder-carried missiles, could facilitate six commandos each, while towing the empty plgs. The birds brought the pigs as close to the shore as possible, thus cutting down the distance the pigs would have to travel on their own. (The pigs were submersible and silent but relatively slow.)

Two miles off the Libyan coast, the lights of Tripoli could be seen glistening in the southeast. Eight commandos slipped quietly into the plgs and headed for shore. The birds stayed behind at the rendezvous point, ready to take action should the situation arise. Once they reached the beach, the commandos left their cigarlike transporters submerged in the shallow water and headed inland, carrying a dark green Trojan cylinder six feet long and seven inches in diameter. It took two men to carry it.

A gray van was parked on the side of the road about one hundred feet from the water, on the coastal highway leading from Sabratah to Tripoli and on to Benghazi. There was hardly any traffic at that time of night. The driver of the van seemed to be repairing a flat tire. He stopped working as the team approached and opened the back doors of the van. He was a Mossad combatant. Without a word said, four of the men entered the van and headed for the city. The other four returned to the water, where they took a defensive position by the submerged pigs. Their job was to hold this position to ensure an escape route for the team now headed for the city.

At the same time, a squadron of Israeli fighters was refueling south of Crete, ready to assist. They were capable of keeping any ground forces away from the commandos, allowing them a not-so-clean getaway. At this point, the small commando unit was divided into three details - its most vulnerable state. Were any of the details to run into enemy forces, they were instructed to act with extreme prejudice before the enemy turned hostile.

The van parked at the back of an apartment building on Al Jamhuriyah Street in Tripoli, less than three blocks away from the Bab al Azizia barracks that were known to house Qadhafi's headquarters and residence. By then, the men in the van had changed into civilian clothing. Two stayed with the van as lookouts and the other two helped the Mossad combatant take the cylinder to the top floor of the five-story building. The cylinder was wrapped in a carpet.

In the apartment, the top section of the cylinder was opened and a small dishlike antenna was unfolded and placed in front of the window facing north. The unit was activated, and the Trojan horse was in place.

The Mossad combatant had rented the apartment for six months and had paid the rent in advance. There was no reason for anyone except the combatant to enter the apartment. However, if someone should decide to do so, the Trojan would self-destruct, taking with it most of the upper part of the building. The three men headed back to the van and to their rendezvous with their friends on the beach.

After dropping the commandos at the beach, the combatant headed back for the city, where he would monitor the Trojan unit for the next few weeks. The commandos wasted no time and headed out to sea. They didn't want to be caught in Libyan waters at daybreak. They reached the birds and headed at full speed to a prearranged pickup coordinate, where they met with the missile boats that had brought them in.

By the end of March, the Americans were already intercepting messages broadcast by the Trojan, which was only activated during heavy communication traffic hours. Using the Trojan, the Mossad tried to make it appear that a long series of terrorist orders were being transmitted to various Libyan embassies around the world (or, as they were called by the Libyans, Peoples' Bureaus). As the Mossad had hoped, the transmissions were deciphered by the Americans and construed as ample proof that the Libyans were active sponsors of terrorism. What's more, the Americans pointed out, Mossad reports confirmed it.

The French and the Spanish, though, were not buying into the new stream of information. To them, it seemed suspicious that suddenly, out of the blue, the Libyans, who'd been extremely careful in the past, would start advertising their future actions. They also found it suspicious that in several instances Mossad reports were worded similarly to coded Libyan communications. They argued further that, had there truly been after-the-fact Libyan communications regarding the attack, then the terrorist attack on the La Belle discotheque in West Berlin on April 5 could have been prevented, since surely there would have been communications before, enabling intelligence agencies listening in to prevent it. Since the attack wasn't prevented, they reasoned that it must not be the Libyans who did it, and the "new communications" must be bogus. The French and the Spanish were right. The information was bogus, and the Mossad didn't have a clue who planted the bomb that killed one American serviceman and wounded several others. But the Mossad was tied in to many of the European terrorist organizations, and it was convinced that in the volatile atmosphere that had engulfed Europe, a bombing with an American victim was just a matter of time. Heads of the Mossad were counting on the American promise to retaliate with vengeance against any country that could be proven to support terrorism. The Trojan gave the Americans the proof they needed. The Mossad also plugged into the equation Qadhafi's lunatic image and momentous declarations, which were really only meant for internal consumption.

It must be remembered that Qadhafi had marked a line in the water at that time, closing off the Gulf of Sidra as Libyan territorial waters and calling the new maritime border the line of death (an action that didn't exactly give him a moderate image). Ultimately, the Americans fell for the Mossad ploy head over heels dragging the British and the Germans somewhat reluctantly in with them. Operation Trojan was one of the Mossad's greatest successes. It brought about the air strike on Libya that President Reagan had promised - a strike that had three important consequences. First, it derailed a deal for the release of the American hostages in Lebanon, thus preserving the Hizballah (Party of God) as the number one enemy in the eyes of the West. Second, it sent a message to the entire Arab world, telling them exactly where the United States stood regarding the Arab-Israeli conflict. Third, it boosted the Mossad's image of itself, since it was they who, by ingenious sleight of hand, had prodded the United States to do what was right. It was only the French who didn't buy into the Mossad trick and were determined not to ally themselves with the aggressive American act. The French refused to allow the American bombers to fly over their territory on their way to attack Libya.

On April 14, 1986, one hundred and sixty American aircraft dropped over sixty tons of bombs on Libya. The attackers bombed Tripoli international airport, Bab al Azizia barracks, Sidi Bilal naval base, the city of Benghazi, and the Benine airfield outside Benghazi. The strike force consisted of two main bodies, one originating in England and the other from flattops in the Mediterranean. From England came twenty-four F-111s from Lakenheath, five EF-111s from Upper Heyford, and twenty-eight refueling tankers from Mildenhall and Fairford. In the attack, the air force F-111s and the EF-111s were joined by eighteen A-6 and A-7 strike and strike support aircraft, six F/A-18 fighters, fourteen EA-6B electronic jammer planes, and other support platforms. The navy planes were catapulted from the carriers Coral Sea and America. On the Libyan side, there were approximately forty civilian casualties, including Qadhafi's adopted daughter. On the American side, a pilot and his weapons officer were killed when their F-111 exploded.

After the bombing, the Hizballah broke off negotiations regarding the hostages they held in Beirut and executed

three of them, including one American named Peter Kilburn. As for the French, they were rewarded for their nonparticipation in the attack by the release at the end of June of two French journalists held hostage in Beirut. (As it happened, a stray bomb hit the French embassy in Tripoli during the raid.)

Ephraim had spelled it all out for me and confirmed some of the information I'd already known. He then went on. "After the bombing of Libya, our friend Qadhafi is sure to stay out of the picture for some time. Iraq and Saddam Hussein are the next target. We're starting now to build him up as the big villain. It will take some time, but in the end, there's no doubt it'll work."

"But isn't Saddam regarded as moderate toward us, allied with Jordan, the big enemy of Iran and Syria?"

"Yes, that's why I'm opposed to this action. But that's the directive, and I must follow it. Hopefully, you and I will be done with our little operation before anything big happens. After all, we have already destroyed his nuclear facility, and we are making money by selling hlm technology and equipment through South Africa."

In the following weeks, more and more discoveries were made regarding the big gun and other elements of the Saddam war machine. The Mossad had all but saturated the intelligence field with information regarding the evil intentions of Saddam the Terrible, banking on the fact that before long, he'd have enough rope to hang himself. It was very clear what the Mossad's overall goal was. It wanted the West to do its bidding, just as the Americans had in Libya with the bombing of Qadhafi. After all, Israel didn't possess carriers and ample air power, and although it was capable of bombing a refugee camp in Tunis, that was not the same. The Mossad leaders knew that if they could make Saddam appear bad enough and a threat to the Gulf oil supply, of which he'd been the protector up to that point, then the United States and its allies would not let him get away with anything, but would take measures that would all but eliminate his army and his weapons potential, especially if they were led to believe that this might just be their last chance before he went nuclear.

Ostrovsky knows that being famous keeps him alive.

The Lavon Affair: Another Mossad False Flag Operation

In July 1954 Egypt was plagued by a series of bomb outrages directed mainly against American and British property in Cairo and Alexandria. It was generally assumed that they were the work of the Moslem Brothers, then the most dangerous challenge to the still uncertain authority of Colonel (later President) Nasser and his two-year-old revolution. Nasser was negotiating with Britain over the evacuation of its giant military bases in the Suez Canal Zone, and, the Moslem Brothers, as zealous nationalists, were vigorously opposed to any Egyptian compromises.

It therefore came as a shock to world, and particularly Jewish opinion, when on 5 October the Egyptian Minister of the Interior, Zakaria Muhieddin, announced the break-up of a thirteen-man Israeli sabotage network. An 'anti-Semitic' frame-up was suspected.

Moshe Sharett Indignation increased when, on 11 December, the group was brought to trial. In the Israeli parliament, Prime Minister Moshe Sharett denounced the 'wicked plot hatched in Alexandria ... the show trial which is being organized there against a group of Jews who have fallen victims to false accusations and from whom it seems attempts are being made to extract confessions of imaginary crimes, by threats and torture ...'.⁴⁹ The trade union newspaper Davar observed that the Egyptian regime 'seems to take its inspiration from the Nazis' and lamented the 'deterioration in the status of Egyptian Jews in general'.⁵⁰ For Ha'aretz the trial 'proved that the Egyptian rulers do not hesitate to invent the most fantastic accusations if it suits them'; it added that 'in the present state of affairs in Egypt the junta certainly needs some diversions'.⁵¹ And the next day the Jerusalem Post carried this headline: 'Egypt Show Trial Arouses Israel, Sharett Tells House. Sees Inquisition Practices Revived.'

The trial established that the bombings had indeed been carried out by an Israeli espionage and terrorist network. This was headed by Colonel Avraharn Dar --alias John Darling-- and a core of professionals who had set themselves up in Egypt under various guises. They had recruited a number of Egyptian Jews; one of them was a young woman, Marcelle Ninio, who worked in the offices of a British company. Naturally, the eventual exposure of such an organization was not going to improve the lot of the vast majority of Egyptian Jews who wanted nothing to do with Zionism. There were still at least 50,000 Jews in Egypt; there had been something over 60,000 in 1947, more than half of whom were actually foreign nationals. During the first Arab-Israeli war of 1948, the populace had some times vented its frustration against them, and some were killed in mob violence or by terrorist bombs. In spite of this, and of the revolutionary upheaval which followed four years later, few Jews-including the foreign nationals-left the country, and fewer still went to Israel. A Jewish journalist insisted: 'We, Egyptian Jews, feel secure in our homeland, Egypt.'⁵²

The welfare of Oriental Jewry in their various homelands was, as we have seen, Israel's last concern. And in July 1954 it had other worries. It was feeling isolated and insecure. Its Western friends-let alone the rest of the world-were unhappy about its aggressive behaviour. The US Assistant Secretary of State advised it to 'drop the attitude of the conqueror'.⁵³ More alarming was the rapprochement under way between Egypt, on the one hand, and the United States and Britain on the other. President Eisenhower had urged Britain to give up her giant military base in the Suez Canal Zone; Ben-Gurion had failed to dissuade her. It was to sabotage this rapprochement that the head of Israeli intelligence, Colonel Benyamin Givli, ordered his Egyptian intelligence ring to strike.

Lavon Givli's boss, Defence Minister Pinhas Lavon, and the Prime Minister, Moshe Sharett, knew nothing of the operation. For Givli was a member of a powerful Defence Ministry clique which often acted independently, or in outright defiance, of the cabinet. They were proteges of Ben-Gurion and, although 'The Old Man' had left the Premiership for Sde Boker, his Negev desert retreat, a few months before, he was able, through them, to perpetuate the hardline 'activist' policies in which he believed. On Givli's instructions, the Egyptian network was to plant bombs in American and British cultural centres, British-owned cinemas and Egyptian public buildings. The Western powers, it was hoped, would conclude that there was fierce internal opposition to the rapprochement and that Nasser's young régime, faced with this challenge, was not one in which they could place much confidence.⁵⁴ Mysterious violence might therefore persuade both London and Washington that British troops should remain astride the Canal; the world had not forgotten Black Saturday, 28 January 1951, in the last year of King Farouk's reign, when mobs rampaged through downtown Cairo, setting fire to foreign-owned hotels and shops, in which scores of people, including thirteen Britons, died.

The first bomb went off, on 2 July, in the Alexandria post office. On 11 July, the Anglo-Egyptian Suez negotiations, which had been blocked for nine months, got under way again. The next day the Israeli embassy in London was assured that, up on the British evacuation from Suez, stock-piled arms would not be handed over to the Egyptians. But the Defence Ministry activists were unconvinced. On 14 July their agents, in clandestine radio contact with Tel Aviv, fire-bombed US Information Service libraries in Cairo and Alexandria. That same day, a phosphorous bomb exploded prematurely in the pocket of one Philip Natanson, nearly burning him alive, as he was about to enter the British-owned Rio cinema in Alexandria. His arrest and subsequent confession led to the break-up of the whole ring-but not before the completion of another cycle of clandestine action and diplomatic failure. On 15 July President Eisenhower assured the Egyptians that 'simultaneously' with the signing of a Suez agreement the United States would enter into 'firm commitments' for economic aid to strengthen their armed forces.⁵⁵ On 23 July --anniversary of the 1952 revolution-- the Israeli agents still at large had a final fling; they started fires in two Cairo cinemas, in the central post office and the railway station. On the same day, Britain announced that the War Secretary, Antony Head, was going to Cairo. And on 27 July he and the Egyptians initiated the 'Heads of Agreement' on the terms of Britain's evacuation.

The trial lasted from 11 December to 3 January. Not all the culprits were there, because Colonel Dar and an Israeli colleague managed to escape, and the third Israeli, Hungarian-born Max Bennett, committed suicide; but those who were present all pleaded guilty. Most of them, including Marcelle Ninio, were sentenced to various terms of imprisonment. But Dr Musa Lieto Marzuk, a Tunisian-born citizen of France who was a surgeon at the Jewish Hospital in Cairo, and Samuel Azar, an engineering professor from Alexandria, were condemned to death. In spite of representations from France, Britain and the United States the two men were hanged. Politically, it would have been very difficult for Nasser to spare them, for only seven weeks before six Moslem Brothers had been executed for complicity in an attempt on his life. Nevertheless Israel reacted with grief and anger. So did some Western Jews. Marzuk and Azar 'died the death of martyrs', said Sharett on the same day in the Knesset, whose members stood in silent tribute. Israel went into official mourning the following day. Beersheba and Ramat Gan named streets after the executed men. Israeli delegates to the Egyptian-Israeli Mixed Armistice Commission refused to attend its meeting, declaring that they would not sit down with representatives of the Cairo junta. In New York there were bomb threats against the Egyptian consulate and a sniper fired four shots into its fourth-floor window.⁵⁶

Moshe Dayan This whole episode, which was to poison Israeli political life for a decade and more, came to be known as the 'Lavon Affair', for it had been established in the Cairo trial that Lavon, as Minister of Defence, had approved the campaign of sabotage. At least so the available evidence made it appear. But in Israel, Lavon had asked Moshe Sharett for a secret inquiry into a matter about which the cabinet knew nothing. Benyamin Givli, the intelligence chief, claimed that the so-called 'security operation' had been authorized by Lavon himself. Two other Ben-Gurion protégés, Moshe Dayan and Shimon Peres, Shimon Peres testified against Lavon. Lavon denounced Givli's papers as forgeries and demanded the resignation of all three men. Instead, Sharett ordered Lavon himself to resign and invited Ben-Gurion to come out of retirement and take over the Defence Ministry. It was a triumphant comeback for the 'activist' philosophy whose excesses both Sharett and Lavon had tried to modify. It was consummated, a week later, by an unprovoked raid on Gaza, which left thirty-nine Egyptians dead and led to the Suez War of 1956.⁵⁷

When the truth about the Lavon Affair came to light, six years after the event, it confirmed that there had been a frame-up; not, however, by the Egyptians, but by Ben-Gurion and his young protégés. Exposure was fortuitous. Giving evidence in a forgery trial in September David ben-Gurion 1960, a witness divulged on passant that he had seen the faked signature of Lavon on a document relating to a 1954 'security mishap'.⁵⁸ Ben-Gurion immediately announced that the three-year statute of limitations prohibited the opening of the case. But Lavon, now head of the powerful Histadrut Trade Union Federation, seized upon this opportunity to demand an inquiry. Ben-Gurion did everything in his power to stop it, but his cabinet overruled him. The investigation revealed that the security operation had been planned behind Lavon's back. His signature had been forged, and the bombing had actually begun long before his approval --which he withheld-- had been sought. He was a scapegoat pure and simple. On Christmas Day 1960, the Israeli cabinet unanimously exonerated him of all guilt in the 'disastrous security adventure in Egypt'; the Attorney General had, in the meantime, found 'conclusive evidence of forgeries as well as false testimony in an earlier inquiry'.⁵⁹ Ben-Gurion was enraged. He issued an ultimatum to the ruling Labour party to remove Lavon, stormed out of a cabinet meeting and resigned. In what one trade unionist described as 'an immoral and unjust submission to dictatorship', his diehard supporters in the Histadrut swung the vote in favour of accepting Lavon's resignation. Lavon, however, won a moral victory over the man who twice forced him from office. In the streets of Tel Aviv and Jerusalem, students demonstrated in his favour. They carried placards reading: 'Bengurion Go to Sde Boker, Take Dayan and Peres with You. We do Not Accept Leaders with Elastic Consciences'.⁶⁰ The affair rocked the ruling establishment, split public opinion, forced new elections and contributed largely to Ben-Gurion's eventual disappearance from public life.

But Lavon was not the only real victim. There were also those misguided Egyptian Jews who paid with their lives or long terms of imprisonment. It is true that when, in 1968, Marcelle Ninio and her colleagues were exchanged for Egyptian prisoners in Israel, they received a heroes' welcome. True, too, that when Miss Ninio got married Prime Minister Golda Meir, Defence Minister Dayan and Chief of Staff General Bar Lev all attended the wedding and Dayan told the bride 'the Six-Day War was success enough that it led to your freedom'.⁶¹ However, after spending fourteen years in an Egyptian prison, the former terrorists did not share the leadership's enthusiasm. When Ninio and two of her colleagues appeared on Israel television a few years later, they all expressed the belief that the reason why they were not released earlier was because Israel made little effort to get them out. 'Maybe they didn't want us to come back,' said Robert Dassa. 'There was so much intrigue in Israel. We were instruments in the hands

of the Egyptians and of others ... and what is more painful after all that we went through is that this continues to be so.' In Ninio's opinion, 'the government didn't want to spoil its relations with the United States and didn't want the embarrassment of admitting it was behind our action'.62

But the real victims were the great mass of Egyptian Jewry. Episodes like the Lavon Affair tended to identify them, in the mind of ordinary Egyptians, with the Zionist movement. When, in 1956, Israeli invaded and occupied Sinai, feeling ran high against them. The government, playing into the Zionist hands, began ordering Jews to leave the country. Belatedly, reluctantly, 21,000 left in the following year; more were expelled later, and others, their livelihood gone, had nothing to stay for. But precious few went to Israel.

Israel's False Flag Attack on the USS Liberty, 1967

"We had been surveilled all morning and part of the afternoon by Israeli forces. They knew who we were. We heard them reporting over radio who we were and how we were sailing and where we were sailing. They saw the flag and everything else. We were in international waters."

...

SCANNING THE SKIES

The U.S. Government had posted the Liberty off the coast of Gaza, in international waters, to monitor developments in the region during the Six-Day War. (The Liberty's mission will be discussed in detail below.) At dawn 8 June, Israeli aircraft began reconnoitering the ship, some flying so close that the pilots could clearly be seen, and as low as masthead height, obviously photographing it. This extensive observation lasted seven hours and involved eight separate observations, at about 0600, 0900, 1000, 1030, 1100, and 1130, 1200 and 1215 p.m. U.S. intercept stations twice overheard Israeli pilots reporting that the ship was American. The visibility conditions were perfect; the ship's American flag was flying free and clear in a good breeze.

At 1400 a well coordinated attack by jet aircraft and torpedo boats began. Jets hammered the virtually unarmed ship with cannon and rockets, and napalmed it. Its forward machineguns were wiped out in the first firing pass, and whatever transmitting antennas survived that pass were disabled by the second. Nine minutes into the attack, crewmen jury-rigged a transmitter to an antenna. But the radiomen discovered that four out of five of the ship's radio frequencies, including the international distress frequency, were being jammed. Ironically, the only time Liberty could transmit was while the jets were firing their missiles. A frantic cry for help was sent to the Sixth Fleet, only 400 miles away and off Crete; despite the Israeli jamming, the Liberty's plea for assistance was received. The patchwork transmitting arrangement ceased functioning soon afterward.

Torpedo boats soon arrived and continued the attack, firing five torpedoes, with one hitting and killing 25 men. They then leisurely circled the defenseless ship for 40 minutes, pumping hundreds of 40mm, 20mm, and 50cal. rounds at wounded men on deck, stretcher bearers and fire fighters. Thinking the ship was about to sink, the crew threw life rafts over the side; the attackers machine-gunned those too. With increased radio activity from the U.S. Sixth Fleet indicating an impending U.S. response (many of the Fleet's messages bore "Flash" precedence), the Israelis suddenly contacted the U.S. embassy and informed it of this "accident." It was probably the longest "accidental" attack in the history of naval warfare an hour and 15 minutes.

Two separate flights of jets from the carriers America and Saratoga were recalled by Secretary of Defense Robert McNamara, the first flight probably because Washington was not absolutely certain of the attackers' identity and was leery of starting a war with the Russians if they were the guilty party. The second flight was recalled after receipt of the Israeli explanation.

MORE EVIDENCE OF GUILT

In addition to the abovementioned circumstances which show that Israel's attack was deliberate the lengthy and careful surveillance, the radio jamming, etc. numerous other details belie Israel's professed innocence. They include: * The Israelis initially claimed they had "mistaken" the Liberty for the Egyptian ship El Quseir. But the El Quseir was only 40 percent the size of Liberty (4000 vs. 10,400 tons). The El Quseir was an old, rustedout horse transport that bore about as much resemblance to the Liberty as a rusty VW does to a new Cadillac. The Liberty was arrayed with numerous specialized antennas, and an ultramodern (for 1967) 16foot microwave dish, a device possessed by no other ship in the world except her sister ship Belmont. She bore standard U.S. Navy markings, which included a freshly painted 10foothigh hull number, and Liberty on the stern.

* The radio jamming is by itself damning evidence that the assailants knew exactly whom they were attacking. Such jamming requires intimate advance knowledge of the target being jammed, obtained by extended monitoring of its signals. And this was selective jamming; it struck Liberty's frequencies and no others.

Afterward, in one of their ever changing explanations, the Israelis claimed to have learned the ship's identity when they heard its distress signals. But the attack continued for sixty six minutes after the first distress signal, which

the Israelis had jammed, was sent. Had this particular Israeli claim been true, they would have recalled the torpedo boats before they even reached the ship.

* The Israelis claimed that the ship's U.S. flag hung limp because there was no wind. Later, when presented with the fact that the flag had been perfectly visible, they claimed that they thought that the ship was an enemy vessel flying false colors. The extended radio monitoring, exposing considerable advance investigation of Liberty's communication facilities, refutes this claim.

* The Israelis claimed that the torpedo boats, after first sighting the ship, had called in the aircraft to attack after the ship refused to identify itself. This is an obvious lie, because the attack was clearly a preplanned and well coordinated onetwo punch employing different branches of the Israeli Defense Forces. The jets were already intent on attacking the ship before the Liberty came into the torpedo boats' radar range. Directly contradicting themselves, the Israelis later claimed that their aircraft had called in the torpedo boats.

* The Israelis eventually admitted that before the attack, their commanders had compared reconnaissance photos of the Liberty with Jane's Fighting Ships. But they claimed that before the attack they twice telephoned the U.S. naval attache in Tel Aviv inquiring whether the Liberty was a U.S. ship and were told that there were no U.S. Navy ships in the area. They claimed that having received a negative reply, they decided that the ship had to be the El Quseir. However, the U.S. embassy in Tel Aviv, and later the naval attache, emphatically stated that no such inquiries were made. The Israelis not only knew the ship's nationality and that she was an "ELINT" ship; they also knew she was the Liberty herself.

* Immediately preceding the attack, an Israeli pilot recognized Liberty as a U.S. ship and radioed this information to IDF headquarters. He was instructed to attack anyway. This dialogue was intercepted at the U.S. embassy in Beirut. Former U.S. Ambassador to Lebanon Dwight Porter revealed the existence of this intercept in 1991.

* Finally, there is evidence, circumstantial but clear, of a relationship between the attack on the Liberty and a postponement of Israel's planned attack on the Golan Heights. The Golan attack was scheduled for 11:30 a.m. on 8 June; the Liberty was spotted by 6 a.m. or earlier; lastminute orders delayed the Golan attack; the Liberty was put out of commission; and the Golan attack occurred shortly thereafter. The vaunted IDF made very few mistakes in that war.

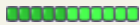

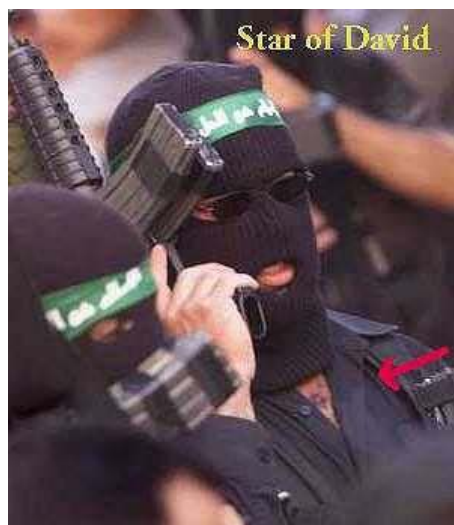

Army General and Head of the PGR Releases Two Israelis Arrested With Guns and Explosives Inside the Mexican Congress

ConchaLOS ANGELES (ACN) - In a mind-blowing development, La Voz de Aztlan has learned that Mexican Army General Rafael Marcial Macedo de la Concha (left) who heads the Procuraduría General de la República [b](Mexican Department of Justice) has released the retired Israeli Defense Forces colonel and presumed MOSSAD agent Salvador Guersson Smecke and Israeli illegal immigrant Saur Ben Zvi after both had penetrated the security of the Mexican Congress and were in possession of guns, hand grenades and explosives.]/B]

This morning La Voz de Aztlan had a personal telephone interview with the Mexican Congressional Press Secretary, Lic. Adriana Lopez, and verified the arrest of the two Israelis after they had entered through the highly secured front entrance of the Palacio Legislativo de San Lázaro. She stated to La Voz de Aztlan that the two terrorists had taken advantage of a situation that occurred around 1700 hours of Wednesday October 10 when a large contingent of Sugar Industry Unionists were entering through the metal detectors. The two Israelis followed about 50 of the unionists to the office of the President of the Mexican Congress Beatriz Paredes. The two Israelis were first pretending to be press photographers but called the attention of the sugar unionists because of their nervous and out of the ordinary behavior. About ten of the unionists confronted them and observed that they were carrying guns and what looked to them to be explosives. They held the two Israelis until Official Congressional Security personnel took them into custody. The head of Congressional Security Salvador Alarcón verified that the Israelis had in their possession nine hand grenades, sticks of dynamite, detonators, wiring and two 9mm "Glock" automatics.

The chamber

Mexican Congressional Press Secretary Lic. Adriana Lopez informed La Voz de Aztlan in the telephone interview that Congressional Security then turned the terrorists Salvador Guersson Smecke, age 34, and Saur Ben Zvi, age 27, to the Procuraduría General de la República (Mexican Department of Justice) which is headed by Mexican Army General Rafael Marcial Macedo de la Concha. Initial reports by the Procuraduría General de la República (PGR) were that both Israelis worked for a private security agency and that they both had gun permits. It turned out that there is no connection of either suspect to any private security agency. The PGR has released the retired Israeli I.D.F. colonel with the official explanation that he had a legal permit to carry a gun. They also released the illegal Israeli immigrant on about \$4,000 bail and the case turned over to the Mexican immigration authorities. Mexican Congressional Press Secretary Lic. Adriana Lopez was surprised to hear from La Voz de Aztlan of the release of the two Israelis.

Concha, GutmanLa Voz de Aztlan has also learned that the Israeli Embassy used heavy handed measures to have the two Israelis released. Very high level emergency meetings took place between Mexican Secretary of Foreign Relations Jorge Gutman, General Macedo de la Concha and a top Ariel Sharon envoy who flew to Mexico City specially for that purpose. Elías Luf of the Israeli Embassy worked night and day and their official spokeswoman Hila Engelhart went into high gear after many hours of complete silence. What went on during those high level meetings no one knows, but many in Mexico are in disbelief at their release. Guns and any

kind of explosive is highly illegal for Mexican citizens and the fact that these two Israelis had them inside the Mexican Congress makes their release highly suspect. What is really going on? Jorge Gutman, the Mexican Foreign Secretary, has strong Zionist connections and himself is of Jewish descent. Mexican Army General Macedo de la Concha has strong connections to the U.S. Military Industrial-Complex and through this to the Israeli Defense Forces. Have any of these connections influenced the decision to release the two Zionist terrorists?

The initial arrests of the two Israelis inside the Palacio Legislativo de San Lázaro made top news on Mexico City television and radio on the evening of October 10. TV Azteca had extensive coverage on the first night and on the following day. La Cronica de Hoy and El Universal both covered the incident the following two days but now it seems that there is a lack of reports. No U.S. media has made any mention, that we know, except one by USAJewish.com this Sunday at: [...] Pravda of Moscow has a note of the initial La Voz de Aztlan article at: [...]

What were the Israelis up to? We think we know. The Vicente Fox government has been very careful of involving Mexico in a war against Islam. The Mexican population as well as the two major opposition political parties, the PRI and the PRD will not allow it. President Bush and the U.S. Zionists want Mexico fully involved in the war principally because if things get tough in the middle east and the oil rich Arabs leave the coalition, the U.S. military machine is going to need alternative sources of oil and PEMEX is just across the border. We believe that the two Zionists terrorist were going to blow up the Mexican Congress. The second phase was to mobilize both the Mexican and US press to blame Osama bin Laden. Most likely then Mexico would declare war on Afghanistan as well, commit troops and all the oil it could spare to combat Islamic terrorism.

Philippine National Police (PNP) operatives apprehended an Israeli suspected to be a member of the al-Qaeda terror network in in Baguio City on June 7.



Arrested was Mera Doutsyky.

Reports reaching the PNP headquarters in Camp Crame, Quezon City, disclosed that Mera was nabbed at about 2 p.m., by joint elements of the Criminal Investigation and Detection Unit and the Bureau of Immigration at the vicinity of the Department of Social Welfare Development in Baguio City.

Authorities also said that Doutsyky was also found to be an undocumented and overstaying alien.

Police said the information they received from the Bureau of Immigration revealed that Doutsyky is a suspected member of the al-Qaeda terrorist cell, an information still unconfirmed by other intelligence agencies.

Doutsyky was turned over to the office of Alipio Fernandez Jr., BI commissioner, in Manila for proper disposition.

Last week, authorities reportedly prevented a possible terror attack coinciding with the 106th celebration of Independence Day.



Explosive materials plenty enough to sink a passenger ship were seized by authorities from arrested terrorist suspect Alejandro Aguirre.

The explosives were seized before these could be shipped to Zamboanga City.

The arrest came following an announcement by the Australian government that terrorists have entered Indonesia from the Philippines in recent weeks to plan a new strategy on assassinating diplomats in lieu of bombing western targets.

The suspect was held on Thursday at Pier 18, North Harbor, Manila allegedly trying to ship seven boxes of explosives, including blasting caps and rolls of detonating cord and fuses.

CSI Forensics Proves Who Killed US Marines - Evidence shows Israel is Guilty!

The Beirut bombing that killed 241 U.S. Marines was "the largest non-nuclear explosion in history," according to General Paul X. Kelley, past-Commandant of the Marine Corps.

On June 8, 1982 - the 15th anniversary of the sneak attack against the U.S.S. Liberty by Israeli forces - Israel launched sneak attacks against Lebanon (weakened by a Mossad campaign of terrorism and false flag operations) and Syria, destroying Syria's air force and defense systems.

President Reagan sent 1,800 marines to Beirut to act as "peace keepers." They were denied to have live ammunition to be able to properly protect themselves. Veterans worried if they, like the crew of the U.S.S. Liberty, were being set up as "live bait."

Around 6:20 am, October 23, 1983, a terrified city is awakened by a deafening explosion. The ground shakes. Have the Israelis begun another bombing rampage? A towering mushroom cloud billows from the rubble of what had been the U.S. barracks at Beirut International Airport where the 1st Battalion 8th Marines had been sleeping

The "official version" put out by the federal government still repeated today was that the explosion was caused by a truck loaded with "2,000 pounds of dynamite" rammed the building. No one with any knowledge of explosives believed the "official version, because that explosion could not have been caused by TNT, just as fuel oil can't melt steel; or as General Parton proved, a Ryder truck of fertilizer could not bring down the Murrah building.

Against the evidence and common sense, immediately, the blame was laid on "terrorists almost certainly Hezbollah" - and guilt by word association blaming two of Israel's bitterest enemies, Iran and Syria. But the official story never tells you.

The Mossad had advance knowledge of the notorious suicide bombing in Beirut but didn't pass on that information to American intelligence. By Way of Deception, Confessions of ex-Mossad agent, Victor Ostrovsky. "Intelligence lies are like the Russian dolls, open one, find another. The real story - like 911 - is even worse than they knew but didn't warn us."

U.S. military intelligence's equivalent of CSI (Crime Scene Investigators), using the most sophisticated, high tech diagnostic tests, forensically examined evidence found at the scene of the terrorist explosion that killed 241 U.S. Marines in Beirut - They know where the bomb came from, but the stunning truth has been suppressed for 23 years. Even without full disclosure of those test results, experts on explosives and terrorism believe more than enough proof exists to establish who is guilty. The truck that blew up the Marine Barracks was loaded with 666 pounds of enhanced RDX "rag bombs."

The Israelis call RDX, "rag bombs," because they use it to kill "rag-heads" or to blame bombings on "rag-heads." Also, the "safest" way to handle it is in "rags" that have been soaked in RDX and dried. Their planted bombs often look like a pile of dirty "rags."

The only active sources of RDX in 1983 were the United States, Canada, France, Sweden, China - and Israel.

But even 666 pounds of RDX (the most powerful, non-nuclear explosive in the world) couldn't have done the damage caused by "The largest non-nuclear explosion in history." Only "enhanced RDX," an Israeli specialty, could have caused that holocaust

Forensic Evidence Points to Israelis Guilty of Massacre of U.S. Marines!

The RDX that killed our Marines was "enhanced" with propane gas and primed with PETN boosters or detonation cord, according to Yosef Bitar, Lebanon's top explosive expert. Bitar is an expert; between 1975 and 1983 he had defused 1,870 bombs! Gas-enhanced RDX bombs are exotic devices. Only explosive experts with a great deal of practical experience can prepare a gas-enhanced bomb. The bomb must be prepared so that first the gas cylinders are exploded to create a cloud in which the RDX is detonated. The gas cloud "amplifies" the exploding plastic charge.

In November of 1982 (when gas-enhanced bombs first started appearing in Lebanon) the Israeli Defense Forces (IDF G-2) intelligence headquarters was destroyed by one of these new devices. Many senior Israeli officers were killed. The Israelis say the explosion was an accident and blame it on a cigarette or match- even though RDX (aka cyclonite, hexogen or T4) base is very stable and difficult to detonate

Israel has made so much RDX and other exotic weapons of mass destruction they are making their own nest uninhabitable. A biological treatment process for wastes contaminated with the explosive RDX (cyclonite) is under investigation in the laboratory using wastewater of a munitions factory in Israel. This study is designed to find solutions for the removal of both RDX and nitrate residues in these wastes, materials that can contribute to groundwater contamination. A bacterium was isolated from soil contaminated by RDX capable of aerobically removing nitrite residues from RDX, which is the first step in the biodegradation of RDX. They spend fortunes of the money congress sends them to study the kinetics of RDX and HMX biodegradation in the groundwater of the Israeli Coastal Aquifer. So much soil and groundwater has been polluted Israel has to import tons of RDX and other nasty chemicals.

The only place that officially admits to making RDX is Chemko in Slovakia pdf. To buy it requires a government license. Chemko has never traded "with an Arab country." However, in letter dated May 2003, the Czech ministry says it has "no objections" to the "application of the company Chemko to issue a license for the export of explosives to Israel (RDX - 55 t, oktogij[HMX] - 15 t)."

The first stage of the present crisis in Lebanon began when former Lebanese Prime Minister Rafik Hariri was assassinated on Feb 14, 2005. Tellingly, the huge bomb used to kill him and everyone unfortunate enough to be within "collateral damage" range was made out of RDX.

Ralph Forbes had appointments to the U.S. Air Force Academy and West Point, but eager to help his country fight Communism he enlisted in the U.S. Marine Corps instead. While on active duty he volunteered for combat missions in both Lebanon and Vietnam. "Thank God, they didn't send me; because today I know the real purposes of these wars were not for America, but against her."
