Spain topples Holocaust Denial Law

Germany's persecution apparatus in turmoil

So, all your efforts were in vain Frau Zypries! (See photo)



A lot of Germans deem the country's Minister of Justice to be an inhuman being spitting hate in all directions. While Germany held the EU-council presidency, Frau Zypries boasted that she had brought the remaining EU member countries into line. Now in the EU including Great Britain, anyone who expressed doubts about the Holocaust story and published non-admissible facts would be thrown into prison. Today anyone doing such a thing anywhere in the EU, said Frau Zypries--with her chest puffed out and a satanic grin on her face--would be "mercilessly" thrown into jail. However, just one year later the Spanish justice put an abrupt end to this furious vixen's violation of human rights. On the 8th November 2007 the Spanish Constitutional Court squashed this harassment law, exported to Spain by the Federal Republic of Germany, in its entirety.

In 1998 judge Santiago Vidal condemned the Spanish intellectual and journalist Pedro Varela before the Municipal Court Barcelona (Juzgado Penal N° 3) to a prison sentence of five years for "Holocaust denial" and "racism". At the same time Vidal ordered the destruction of 20,000 confiscated books.

The conviction of Spain's most active of human rights campaigner was based on the Holocaust denial law created in 1996 under pressure from Germany (artículo 607.2, Código Penal).

However, both Catalanian courts of appeal, consisting of three judges of Catalonia's highest court (Audiencia Provincial), decided that article 607.2 of the Spanish Criminal Code (Holocaust denial law) was incompatible with the human right of freedom to express one's opinion. Therefore, the judges of "Audiencia Provincial" referred the case of Pedro Varela to a fundamental decision by the Spanish Constitutional Court of Justice in Madrid.

Pedro Varela's passport was confiscated and during a period of ten years he was subjected to unbelievable repressive measures. He not only had to endure repeated raids but also put up with large financial losses resulting from the renewed seizure of thousands of books.

On the 8th November, 2007, eleven years after the start of the

prosecution of the human rights activist, the 12 highest judges of Spain's Constitutional Court in Madrid (El tribunal Constitucional) decided not only regarding the Holocaust denial law but also on the fate of the persecuted dissident Pedro Varela. The decision by Spain's highest judges will not be to the liking of Germany's Minister of Justice Brigitte Zypries and her band of persecutors at all. The "Holocaust denial law", according to the highest Spanish judges, is not compatible with the right guaranteed in the Spanish Constitution of the free expression of opinion.

The judges did not accept as valid the argument that denying the Holocaust would violate the human dignity of Jews and threaten their existence. The judges argued that the free expression of opinion could possibly offend some individual or group of individuals--indeed this is the distinguishing characteristic of freedom of expression of opinion. According to the judges one can not make the basic human right of freedom of expression of opinion dependent on the sensitivities of an individual or of certain groups.

In Spain from now on Holocaust research may no longer be prosecuted as a criminal offence.

Further details to this very significant judicial ruling for Europe will follow.
