

Possible Prison Rail Cars Hidden Just North of Cincinnati Metro Area-Why?

STEVE.....

I RECEIVED A FORWARD OBSERVOR REPORT FROM SOME CALLED THE "BRAKEMAN" WHO I BELEIVE MAY IN FACT BE A RAILWAY EMPLOYEE OR AT LEAST SOMEONE WHO PERHAPS USED TO WORK ON THE RAILROADS.

NO PICTURES OR FURTHER INFORMATION WAS GIVEN BUT SINCE I HAVE ALSO SEEN THESE TYPE CARS PARKED ON SIDINGS IN RURAL AREAS AND HAVE HAD REPORTS OF SPECIAL TYPE "CATTLE CAR" TYPE RAILCARS (THOUGH SLIGHTLY DIFFERENT WITH LESS VISIBILITY OF INSIDE OF CAR) WHICH MAY EVEN HAVE CHAINS AND SHACKLES INSIDE, I THOUGHT IT MIGHT BE VITAL TO REPORT THIS TO THE LISTENERS AND TO THE READERS OF YOUR WEB SITE. ARE THESE PREPOSITIONED FOR SOME NEED IN CINCINNATI NECESSITATED BY MARTIAL LAW?

WITH MARINES PRACTICING FOR MARTIAL LAW IN INDIANAPOLIS, THE THREAT OF POSSIBLE FALSE FLAG ATTACKS, AND THE THREAT OF NUCLEAR STRIKES BY RUSSIA ON CONUS IF THE U.S. JOINS ISRAEL IN ATTACKING IRAN, WE NEED TO BE PAYING ATTENTION TO ANY DETAIL OR ANOMALY WHICH MIGHT IN FACT GIVE US A HEADS UP ON THE POSSIBILITY OF SOME REDLIST OR BLUE LIST PICK-UP , MARTIAL LAW AND CONCENTRATION /SORTING OF POPULATIONS DUE TO TERROR EVENT, NUCLEAR WAR, OR THE OUTBREAK OF SOME BIOWEAPON PLAGUE.

IN A SECTION HIDDEN FROM VIEW BY WOODS.

THE FOLLOWING SHOULD BE LOOKED FOR OR OBSERVED AND REPORTED ASAP.

1.
PRISON RAILCARS SITTING NEAR METRO AREAS OR ADJACENT RURAL AREAS WHERE NORMALLY THEY WOULD NOT BE SEEN.
2.
MILITARY VEHICLES AND UNITS MOVING IN LARGER NUMBERS IN CONUS OR IN AREAS WHERE THEY ARE RARELY SEEN
3.
UNUSUAL NUMBERS OF MILITARY FLIGHTS TAKING OFF OR LANDING ...ESPECIALLY IN AREAS WHERE SAID TRAFFIC IS NOT USUAL.
4.
ANY DRILLS BEING STAGED BY MILITARY, POLICE, AND MEDICAL PERSONNEL...PARTICULARLY DEALING WITH URBAN TRAINING, TERRORISM, OR NBC ATTACKS.....ESPECIALLY IF CHECK POINTS ARE BEING SET UP.

UNUSUAL DOD X TRAINS MOVING WITH ARMED GUARDS WHETHER MILITARY OR PERHAPS BLACK/GREY/NAVY BDU WEARING PRIVATE SECURITY.....ESPECIALLY IF THEY ARE MOVING ARMOR, BALES OF RAZOR WIRE, FOREIGN MILITARY EQUIPMENT, OR "CATTLE CARS" ESPECIALLY IF PEOPLE ARE SEEN OR HEARD INSIDE THEM.
6.
ANY U.S. OR FOREIGN TROOPS ARRIVING FOR TRAINING IN TOWNS OR CITIES OR EVEN IN NATIONAL FORESTS, STATE PARKS, OR LOCAL LAKES OR NATURE PRESERVES.....INCLUDING GOLF COURSES OR EVEN REMOTE AREAS OF WATER TREATMENT PLANTS, ELECTRICAL HIGHLINE RIGHT OF WAYS, OR OTHER UTILITY SUBSTATIONS WHERE SOMETIMES BARBED OR RAZOR WIRE ATOP CHAIN LINK FENCING ENCLOSSES SUBSTANTIAL
7.
LARGE NUMBERS OF MILITARY OR PLAINLY PANINTED FUEL TANKER TRUCKS TRAVELLING IN CONVOY
8.
MULTIPLE WHITE SEMI TRACTOR /TRAILER RIGS WITH LITTLE IF ANY MARKINGS ON THEM
9.
LOW FLYING MILITARY HELICOPTERS IN AREAS WHERE THEY ARE NOT NORMALLY SEEN.....ALSO SIGHTINGS OF DRONE AIRCRAFT, OR HELOS IN MULTIPLES EVEN THOUGH THEY ARE PAINTED IN CIVIL AVIATION COLORS LIKE SAY WHITE WITH TEAL OR BLUE TRIM.
10.
ANY ODD SCHOOL LOCK DOWN DRILLS OR TRANSPORT OF STUDENTS TO DIFFERENT VENUES WHERE THEN THEY ARE TOLD THIS WAS AN ANTI-TERRORISM DRILL.
