One can't help from wondering, is it required that everyone in the Fed be Jewish? Or to have Jewish connections and fealty? The answer is profoundly...and historically...obvious: unless you're Zionist kosher, you're out of luck.

WHETHER OR NOT these 'acclaimed' financial 'experts' — along with the Fed's Chairman, Ben Shalom Bernanke (<http://www.federalreserve.gov/aboutthefed/bios/board/bernanke.htm>) — will serve the American people or international Zionist

interests, seems moot. History doesn't lie. Yet no one appears to be complaining that the same kosher cabal which oversaw America's financial catastrophe and looted the US to the core, will continue to run the show.

Although these rubber-stamped 'nominees' aren't likely to alter the Fed's current interest-rate policy, they will indeed reinforce the Fed's activist bent to regulate "risk-taking" (a deceptive lie (<http://www.realzionistnews.com/?p=497>)) across the financial system and tighten consumer regulation (which will ultimately restrict (<http://www.realzionistnews.com/?p=497>) consumer credit options.) These responsibilities will expand (<http://www.realzionistnews.com/?p=497>) the Fed's powers once Congress passes Obama's Finance Reform bill (<http://www.realzionistnews.com/?p=497>) ...yet one more incredible, unconstitutional outrage.

"The Federal Reserve system is going to be reshaped," said (<http://online.wsj.com/article/SB10001424052748704423504575212600364869846.html>) Vincent Reinhart, a former top Fed staffer now at the American Enterprise Institute. "The new governors will certainly be activist in their ability to set regulations and enforce those regulations." Reshaped? That's like re-shaping cookie dough...it's still makes cookies no matter how you lay it on the baking sheet.

Who can state it more clearly than a propagandist from the Jewish-run (http://us.altermedia.info/zionism/the-neocon-zionist-aei_449.html) American Enterprise Institute? "THE FEDERAL RESERVE IS THE CHIEF CULPRIT BEHIND THE ECONOMIC CRISIS," declared (<http://www.ronpaul.com/on-the-issues/audit-the-federal-reserve-hr-1207/>) patriot hero Rep. Ron Paul when introducing his Federal Reserve Transparency Act (<http://www.govtrack.us/congress/bill.xpd?bill=h111-1207>) to the House of Representatives on February 26, 2009.

"Since the Federal Reserve Bank's creation in 1913 the dollar has lost more than 96% of its value," Ron Paul continued (<http://www.ronpaul.com/on-the-issues/audit-the-federal-reserve-hr-1207/>) , "and by recklessly inflating the money supply the Fed continues to distort interest rates and intentionally erode the value of the dollar."

The bill, although it remains hamstrung (<http://www.opencongress.org/bill/111-s604/show>) in the Senate and voted against (<http://www.ronpaul.com/2009-11-19/audit-the-fed-amendment-passes-43-26/>) by many Jews in the House, (and would doubtless be vetoed by Zionist-owned Obama), is Ron Paul's attempt to pry open the mouth of Ben Shalom Bernanke who refuses (<http://sanders.senate.gov/newsroom/news/?id=3565601c-6a0c-4918-ad8a-a8f6162a05a2>) to tell the American people to whom he doled out \$2 trillion in bailout funds. After getting (<http://whatreallyhappened.com/WRHARTICLES/legalcounterfeit.php?q=legalcounterfeit.php>) House and Senate approval for his bill and stepping up his attack (<http://www.encyclopedia.com/doc/1G1-16835330.html>) on Fed Chairman Alan Greenspan for "failing to provide" essential documents concerning its check transport system, President Clinton intervened and turned down (<http://whatreallyhappened.com/WRHARTICLES/legalcounterfeit.php?q=legalcounterfeit.php>) the legislation. His reason? Clinton claimed (<http://www.campaignforliberty.com/article.php?view=81>) that ongoing audits would "run the risk of

undermining market confidence in the Fed." Comrade Clinton follows orders well.

Rahm Working With Fed To Beat Back Audit:

The White House, Federal Reserve and Wall Street lobbyists are kicking up their opposition to an amendment to audit the Fed as a Senate vote approaches, Sen. Bernie Sanders (I-Vt.), the lead sponsor of the measure, said on Monday.

Banking Committee Chairman Chris Dodd (D-Conn.), who is shepherding the bill through the Senate, told Sanders Monday afternoon that "there's a shot we'll be up tomorrow," Sanders told HuffPost.

In the spring of 2009, Sanders brought a similar amendment to the Senate floor and won 59 votes. Eight senators who voted against it then are now cosponsors of his current measure.

be enslaved — by Jewry, by the State, by their partners.

The only question is, if Western Christians and advocates of Western Civilization are going to rise up, fight back, re-take the levers and power and restore Christianity to its rightful moral authority, or if they are a spent force destined to go down the tubes with the masses of "liberalized" (but actually enslaved) cattle.

Sadly, there is no middle way. The Jewish supremacists and their fanatical useful idiots simply won't allow it.

They want to strangle Christianity, Islam and any other challengers or opponents of their totalitarian Jewish supremacy to the last man, and always have — from the Jewish Bolsheviks who murdered millions straight through to the neocons and neolibers of today — Zionists all.
